- Item for Discussion and Possible Action CIS: Wells Fargo Divestiture. (Tabled 10-0-1. AM; NJ JC, NJ; JW, NC; SS, ID, JW, WK, AM, RM//GF)
  - a. The Neighborhood Committee proposes that: the Venice Neighborhood Council (VNC) requests that the following statement of "Support" be attached to Council File 17-0330: "Wells Fargo Bank/Options for Divestment." The Venice Neighborhood Council supports "CF 17-0330: "Wells Fargo Bank/Options for Divestment." We support ending the City of Los Angeles' financial ties with Wells Fargo for their involvement in fraudulent and unethical conduct. It is incumbent on the City to ensure that institutions sustained with taxpayer dollars support socially and environmentally responsible endeavors, and that it desist from doing business with institutions that violate the ethical standards which Angelinos hold. Furthermore, It is crucial for Los Angeles to direct taxpayer resources towards banking institutions and portfolio resources that emphasize investment in renewable energy in accord with the City's own goals of having a 100% renewable energy portfolio. Furthermore, the establishment of a public bank for the funds of the City of Los Angeles should be considered in conjunction with the considered divestment. During the major economic crash of 2008, the State Bank of North Dakota turned record profits while private institutions were forced to ask for public bailouts. This type of control over funds allows investment opportunities directly benefiting the City such as rebuilding our crumbling infrastructure, transitioning to a green energy grid, and bolstering public transportation options and increasing housing stock.
