WHEREAS haul trucks have been staging for construction projects on Lincoln Boulevard and surrounding streets in Venice for years, largely for projects taking place in surrounding municipal and county jurisdictions such as Santa Monica where haul trucks are required to pay permit fees to stage, rather than projects occurring in our neighborhood or city where no such fees are required;

WHEREAS such trucks are both a nuisance and a hazard to the Venice community, in that, for example, they:

- block access to businesses on Lincoln Boulevard,
- park in "red zones," which, in addition to other things, impedes drivers' lines of sight as they pull out onto Lincoln Boulevard.
- park on our residential streets, at times blocking access to our homes,
- pollute our air when they leave their trucks running while parked, and
- disturb our sleep because of staging beginning as early as 5 a.m.;

WHEREAS Los Angeles City Councilman Bonin has recently submitted Motion 16-0238 to the City Council, attached as Exhibit A, asking the Department of Public Works to report on current and potential City controls and requirements relative to haul trucks, including a permit requirement for haul route trucks that utilize the City's public right-of-way;

Whereas: The Big Blue Bus, a City of Santa Monica department providing bus service to adjacent cities and communities, has made major route changes in Venice to its # 1 Bus Route (providing service between Venice and UCLA) effective February 21, 2015 that have created hazardous traffic conditions, as outlined below, both inconveniencing local residents and jeopardizing their safety and that of pedestrians, cyclists, and drivers, without holding public meetings in Venice to gather input on the changes prior to their becoming effective, and

Whereas: Big Blue Bus Route #1 will operate buses along Ocean Avenue up to 93 times each way per day on the new routing and will make stops in both northbound and southbound directions at South Venice:

- Ocean Avenue is a short, narrow, north-south residential street between Venice and Washington with single traffic lanes in each direction, shared bike lanes, parking only on one side of the street with speed bumps, and is already jammed with traffic going to and from Santa Monica, Marina del Rey and now Playa Vista and therefore hazardous for pedestrians, cars and bicycles wishing to ingress and egress from side streets, and
- There is no room to pass or see around a stopped bus on Ocean Avenue, causing frustration for drivers trapped in traffic and creating more hazardous conditions as traffic moves to less congested but more residential streets and alleys

Whereas: Big Blue Bus #18 will operate on both 4th Street and Rose Avein Venice, both narrow, single lane in each direction, mixed use corridors that already suffer from heavy traffic and hazardous conditions that generate frequent trips along alternative routes in residential neighborhoods, exacerbating already hazardous conditions, and

Whereas: the new Big Blue Bus routes have removed service along California Ave in the Oakwood community to Walgrove Blvd and Venice Blvd, inconveniencing residents who rely on the bus to get to shopping areas on Lincoln and to Animo High School, Mark Twain Middle School and Venice High School.

- Ocean Avenue is a short, narrow, north-south residential street between Venice and Washington with single traffic lanes in each direction, shared bike lanes, parking only on one side of the street with speed bumps, and is already jammed with traffic going to and from Santa Monica, Marina del Rey and now Playa Vista and therefore hazardous for pedestrians, cars and bicycles wishing to ingress and egress from side streets, and

Whereas: Big Blue Bus #18 will operate in Venice on 4th Avenue (a very narrow residential street including a section with a steep hill, creating a great deal of engine noise and hazardous conditions) as well as on Rose Avenue in an area already troubled with heavy traffic (that generates frequent trips onto neighborhood streets by vehicles seeking to escape grid-lock conditions on Rose) and 7th Street, a residential street currently suffering from heavy traffic as vehicles travelling on grid-locked Lincoln Blvd seek an alternate route, and

Whereas: the new Big Blue Bus routes have removed service along California Ave in the Oakwood community for Walgrove Blvd and Venice Blvd, inconveniencing residents who rely on the bus to get to shop-ping areas on Lincoln and to Animo High School, Mark Twain Middle School and Venice High School, and

Whereas: the Venice Neighborhood Council thanks Councilmember Bonin for arranging a meeting with the Big Blue Bus on 3/9/2016 (attended by over 200 Venice stakeholders) where several alternative routes were submitted for evaluation by the Big Blue Bus to alleviate the problems created by the new Route 1 and Route 18 transit corridors.
