**MOTION:** The Venice Neighborhood Council approves the project as presented (2080 sq.ft restaurant, 580 sqft retail/takeout, 1100 sqft commercial kitchen, 1100 sqft restaurant kitchen; 81 total seats), with all conditions included LUPC Staff Report, which include:

- 1) Hours of Operation limited to Sunday-Thursday 7:00AM to 10:30PM and Friday-Saturday 7:00AM to 11:30PM,with the patio closing one hour earlier on each night,
- 2) Loading hours between 9AM and 3PM and no deliveries on Sunday,
- 3) 12 onsite parking spaces including 1 ADA, and at least 20 bicycle spaces,
- 4) Type 41 CUB (beer and wine, onsite only)
- 5) Compliance with the Lincoln Blvd Community Design Overlay on the entire project site,
- 6) All abandoned curb cuts filled in,
- 7) No music to be played on the patio at any time,
- 8) Noise mitigation elements including extensive landscaping, particularly in the outdoor patio,
- 9) 5 year plan approval from the Certificate of Occupancy on the CUB. LUPC MOTION MADE BY JAKE KAUFMAN, SECOND BY JORY TREMBLAY PASSED LUPC BY VOTE: 8-1

**MOTION**: The VNC opposes the current WRAC Motion, which reads:

We, the members of the Westside Regional Alliance of Councils, oppose Amending Motion 31B, submitted January 30, 2013 to Council File 11-0262, on the following grounds:

- 1. Lack of sufficient staff support and lack of a funding mechanism
- 2. Inability to presently enforce codes
- 3. Anticipated 10% across the board budget cuts to all City departments slated for FY 2013-2014
- 4. Complete lack of transparent fiscal analysis

We further strongly oppose the continued gutting of the R1 and other low density residential zones in the City of Los Angeles. The General Plan of the City of Los Angeles protects the residential character of these zones. The City is therefore required by law to prepare a General Plan Amendment and to produce a full Environmental Impact Report in compliance with CEQA

**MOTION**: The VNC Board amends the Bylaws Article IV.A. and Article X. Sections 2.B. and 2.C. to correct errors in the last election, and returning to the procedures outlined in Appendix B. which were used in the election four years ago run by the City Clerk's Office. See Exhibits - A (marked up bylaws) & B (Board Structure and Voting).

#### ARTICLE IV: STAKEHOLDER

- A. "Stakeholder are defined as Non-Factual Stakeholders and Factual Basis Stakeholders.
- a. "Non-Factual Basis Stakeholders" are defined as individuals who live, work, or own property within the VNC boundaries
- b. "Factual Basis Stakeholders" are defined as those who declare a stake in the neighborhood and affirm a factual basis for it.

#### ARTICLE X: ELECTIONS Section 2: Governing Board Structure and Voting

- B. Community Officers:
- 1. Thirteen (13) Community Officers are elected at-large by the non-factual-
- basis Voting Members.
- 2. One (1) factual-basis Community Officer is elected by all voting members.
- 3. Factual-basis Voting Members shall be entitled to run only for the one (1) factual-basis Community Officer.
- C. Voting:
- 1. Voting for election of Officers shall be by ballot.

- 2. If more than two (2) candidates are running for an Executive Officer position, a plurality shall be sufficient to elect unless the election procedures direct otherwise.
- 3. No voting by proxy is allowed.
- 4. Each factual-basis Voting Member shall be entitled to cast one (1) vote for a factual-basis Community Officer candidate. If more than one (1) factual-basis candidate is on the factual-basis ballot, the factual-basis candidate with the highest vote total shall be elected. In the event that there are no factual-basis candidates, the Community Officer receiving the next highest vote total shall be elected.
- 5. Each non-factual-basis Voting Member shall be entitled to cast votes as follows: One (1) vote for President One (1) vote for Vice President One (1) vote for Secretary One (1) vote for Treasurer One (1) vote for Communications Officer One (1) vote for Community Outreach Officer One (1) vote for Land Use and Planning Committee Chair One (1) vote for only one (1) Community Officer. This may be either a Factual Basis Community Officer or a Community Officer. The Community Officer candidates with the thirteen (13) highest vote totals shall be elected; EXCEPT, if there is no factual-basis candidate, the Community Officer candidates with the fourteen (14) highest vote totals shall be elected.

#### Section 3: Minimum Voting Age

Any Stakeholder who is sixteen (16) years or older, or a junior or senior in high school, may vote.
