A <u>Provide public access to the USPS-owned Edward Biberman mural</u> Greta Cobar on behalf of Free Venice Beachhead, gretathegreat99@aim.com

MOTION: The Edward Biberman 1941 "Story of Venice" mural featuring Abbot Kinney, housed in the 1939 Work Projects Administration building that previously was the Venice Post Office, was removed from the wall by the building's new owner, Joel Silver. The mural is still the property of the USPS (United States Postal Service). The covenant between Joel Silver and the USPS concerning the mural states that the mural will be available for public viewing six days out of the year by appointment only. This contradicts the community's input to the USPS and it defies the purpose of a mural, which is made to be available to the public. The building will be under renovation for the next two years and the mural will not be available to the public during that time period. In order to provide public access to this public work of art, the mural needs to be moved to a public location, such as the Abbot Kinney library.

Whereas the City Council believes that the Neighborhood Councils do not inform their stakeholders about Council initiatives;

Whereas the City Council requests better participation in city issues by Neighborhood Councils; Whereas Councilmember Parks held hearings at Education and Neighborhoods Committee regarding Neighborhood Council participation in city issues;

Whereas yet again, the City Council, without any warning or advance notice, introduced a motion on January 4, 2013 to place a three billion dollar bond measure on the May ballot with a vote scheduled to be taken on January 10, 2013, thereby again silencing their stakeholders' voice in this matter:

Whereas the Venice Neighborhood Council has already adopted and transmitted a position to the City Council asking for 60 days time for Neighborhood Councils to be able to weigh in on issues;

Be it resolved that the VNC Board instructs the President to immediately transmit the VNC's opposition to the recent City Council action which would have precluded the Neighborhood Councils and their stakeholders from weighing in on the ballot measure.

Furthermore, the VNC demands that a City Council decision on major citywide items, including all proposed tax increases, allow for a 60 day vetting period so that the 95 certified Neighborhood Councils have an opportunity to hold a Brown Act compliant meeting and report back to the Councilmembers with their stakeholders' views.

B <u>Speed Monitoring Radar Signs on Pacific Blvd</u> Marc Saltzberg on behalf of the Neighborhood Committee <u>VicePresident@VeniceNC.org</u>

MOTION: Whereas, it is the responsibility of the City of Los Angeles to provide for the safe flow of traffic on city streets, roads and boulevards and,

Whereas, traffic on Pacific Blvd in Venice does not flow safely as evidenced by the high number of accidents between Navy Street and Washington Blvd (see Appendix 1) and,

Whereas, a comprehensive traffic study has not been completed for Pacific Blvd but excessive vehicle speed has been a factor in many of the reported accidents and,

Whereas, Speed Monitoring Radar Signs are known to have a "calming" effect on traffic;

The Venice Neighborhood Council agrees to set aside \$500 of Community Improvement funds for installation of Speed Monitoring Radar Signs to demonstrate its commitment to improve traffic safety in the Pacific and Brooks area and asks Council District 11 and the Mayor's Office to find ways to provide the additional funding required to complete the installation of Speed Monitoring Radar Signs on Pacific in the vicinity of Brooks Ave. When these funds are identified the VNC asks CD11 to introduce a City Council Motion asking the City to install the Speed Monitoring Equipment on an expedited schedule.

This resolution shall be sent to Los Angeles Mayor Antonio Villaraigosa, City of Los Angeles Council District 11, the Los Angeles City Council and the Los Angeles Department of Transportation.
