As per article V, section 7 of the VNC by-laws, *Absences: If an Officer fails to consistently attend those meetings at which he or she is expected, the Board may remove the Officer and declare the seat vacant. Officers are expected to attend all Board of Officers and Stakeholder meetings. Absence from four (4) consecutive meetings or seven (7) or more meetings during the previous twelve (12) months shall be deemed a failure to consistently attend. Therefore be it resolved that the Venice Neighborhood Council shall file a Community Impact Statement in support of Council File 15-1022-S2 and demand the City suspend online voting unless and until it can show evidence that the online model is complete and secure as contracted for, that the City will provide proper outreach, that the Department can show it has returned to its core mission of supporting NC's, and can truly support neighborhood councils per its Charter mandate, and allow all of the councils, per the Charter, Ordinance and Plan, to self-rule for the benefit of its stakeholders, and to allow the NC's to determine whether it should offer online, self-determination and age specific for its voters.
