Motion: Driving Donations to Professional Service Providers

Whereas, professional homeless service organizations, city officials, and law enforcement all agree that street donations of food, clothing, and other items often do more harm than good by disrupting the process of helping people get off the street -- creating dangerous and unclean environment for both the housed and unhoused, and costs the city tens of thousands of dollars a year in street cleanup and trash collection costs.

Be it resolved that the VNC sign the attached letter to be handed out to those making street donations asking them to partner with Venice service agencies instead of dropping donations on the street.
