## 5. Discussion of PTC Plan and Presentation

- Talked about creating a slide show for presentation to VNC Board in April 2019, no action, continue to refine 6. Discussion Commuter Traffic – Lincoln Blvd, express bus lane
- Motion:

1. Send the Council Office, LADOT and Caltrans a request recommending the Express Bus Lane on Lincoln Blvd. now existing in Santa Monica City (SMC) be extended to Jefferson Blvd. during the same commuter hours as posted in SMC. (Northbound traffic 7-9am M-F, Southbound 3-6pm M-F.) Whereas the VNC realized the only to make the buses attractive for riders to get out of their cars and to ride the buses is if the buses offer a better solution than single occupancy vehicles; and whereas; Venice is heavily impacted by North/South bound commuter cut-through traffic due to the housing developments in the communities to the south and the job opportunities to the North in SMC; whereas the solution which is existing in SMC has been proven to improve bus service with little to zero impact on local businesses that lose curbside parking during commuter restricted hours; whereas the businesses on Lincoln Blvd need to participate in helping to solve the traffic problems all of Venice and the soundings region is feeling due to the number of cars on the roads. ## 7. Discussion Re: Crossing Light at Venice Blvd and Shell Av crosswalk Motion:

Send the Council Office and LADOT a request to add a crosswalk signal control at the intersection of Venice Blvd at Shell Ave. Whereas, during the day it is a very busy street with cars traveling in excess of 40 mph and motorists don't see people in this popular cross walk, and whereas; at night it is almost impossible to cross safely due to the motorist rate of travel and the existing illumination; whereas there have been several near fatal accidents involving pedestrians using the crosswalk.
