10A CIS in support and amendment of CFs 20-0047 and 19-0400 providing for protection for tenants in protected units.

MOTION: The VNC shall submit a Community Impact Statement (CIS) in support of CFs 20-0047, 19-0400 (passed at 9/30/20 City Council Meeting on Consent) WHEREAS the City of Los Angeles is in a dire shortage of AFFORDABLE housing, including low income and moderate income units; and WHEREAS SB 330 was passed by the State Legislature and chaptered on January 1, 2020 and provides enhanced protections for those tenants in "protected units," defined under to include rental units subject to the Rent Stabilization Ordinance (RSO) which in the City of Los Angeles are better described as Rent Stabilized Units (RSO). The protections include: require replacement of housing units must be in the same number as those demolished; require replacement of "protected units" when there is no housing construction to be replaced on a 1:1 basis; prohibit removal of Protected Units without replacement provides that tenants may remain in their housing unit until 6 months prior to commencement of construction; does not differentiate between ministerial or non-ministerial construction of housing developments when applying these enhanced protections; provides that tenants in "protected units" have the First Right of Return in any replacement housing constructed as a result of demolition; provides for legal recourse for any interested party, including a

tenant, against the City of Los Angeles if the protections are complied with and enforced. that an affected city or an affected county shall not approve a housing development project that will require the demolition of occupied or vacant protected units, unless:

- 1. The project will replace all existing or demolished protected units;
- 2. The housing development project will include at least as many residential dwelling units as the greatest number of residential dwelling units that existed on the project site within the last five years;
- 3. Any existing residents will be allowed to occupy their units until six months before the start of construction activities with proper notice; and
- 4. The developer agrees to provide: (i) Relocation benefits (as already permitted by LAMC) to the occupants of those affordable residential rental units; and (ii) A right of first refusal for a comparable unit available in the new housing development affordable to the household at an affordable rent. WHEREAS, SB 330 provided for permit streamlining to expedite approval of Housing Development Projects RESOLVEDWHEREAS, that SB 330 provides for the rights and protections above, and that the City of Los Angeles Department of Planning, Department of Building and Safety, and HCIDLA have not yet demonstrated the City of Los Angeles' compliance have not been complying with SB 330 and have not been enforcing those protections listed in the bill.

Therefore, the Venice Neighborhood Council insists that the City of Los Angeles comply with the provision of SB 330 immediately to minimize the effects of displacement in the

- 1. Department of Planning, Department of Building and Safety, and HCIDLA create clear processes to implement SB 330 provisions to administrative and ministerial (also known as by right) projects in the City, as well as, discretionary projects;
- 2. Department of Planning, Department of Building and Safety, and HCIDLA requirements for one-to-one ratio replacement-units include that replacement units are: a. "Comparable" (i.e., same number of bedrooms); and b. Separate, distinct, and in addition to affordable housing units required by any existing incentive programs, such as Density Bonus.
- 3. The City create a monitoring process for tenants' right to return to units and include a discussion as to income guidelines, inclusive of those who are moderate-income.
- 4. City Attorney create legal mechanism for tenant actions against a landlord that violates eviction procedures and first right of refusal under SB 330, a. including an award of attorney fees for a prevailing tenant; "including an award of attorney fees for a prevailing tenant to be capped at \$500."
- 5. City Attorney to clarify whether implementation of SB 330 supersedes provisions of the Mello Act, which provide for alternatives to replacement of affordable units (i.e., feasibility studies).
- 6. The City create a monitoring program to track the effect of streamlining provisions of SB 330 on project permitting from submission to issuance of a certificate of occupancy.
- 7. The City Attorney complete a legal analysis of whether an exemption to SB 330 exists for "mom and pop" landlords who owner occupy a unit within multi-unit properties of 4 units or less. Whereas paragraphs for 10A Recommended by LUPC 6-0-0

MOTION: The Venice Neighborhood Council shall file a Community Impact Statement (CIS) in support of Council File 20-1213 upon addition of the following amendments to include floods, tsunami evacuation zones, sea level rise, and groundwater rise throughout the motion. (In *italics* below):

"...Linking the update of the Safety Element to the update of the Housing Element of the General Plan will allow our City to balance its housing needs in a way that protects communities in Very High Fire Hazard Severity Zones and flood zones and tsunami evacuation zones, while bolstering our resilience to wildfires and other natural disasters. It will also encourage the regular maintenance of the City's Safety Element to prepare Los Angeles for potentially more intense and frequent wildfires flooding, sea level rise, and groundwater rise as a result of climate change...

"I THEREFORE MOVE that the Los Angeles Department of City Planning, with assistance from the Los Angeles Emergency Management Department (EMD), Los Angeles Department of Transportation, the Los Angeles Fire Department (LAFD), and relevant departments, to report back on the capacity, safety, and viability of existing and potential evacuation routes in VeryHigh Fire Hazard Severity Zones, and flood zones and identify the policies and development standards, including land use and building restrictions, necessary to support these evacuation routes. I FURTHER MOVE that the City Council direct the Los Angeles Department of City Planning, with assistance from the Los Angeles Emergency Management Department (EMD), the Los Angeles Fire Department (LAFD), and relevant departments, to amend the General Plan by incorporating the Local Hazard Mitigation Plan and Office of Planning and Research's "Fire Hazard Planning" and flood, groundwater and sea level rise planning provisions into the Safety Element concurrent with the ongoing update of the Housing Element. I FURTHER MOVE that after reviewing the update to the Safety Element of the General Plan, the City Planning Commission submit its report and recommendations to the City Council."
