Whereas, per information in https://www.latimes.com/california/story/2020-12-12/los-angeles-tinyhomes-homeless? amp=true:

- Under pressure from a federal lawsuit to get homeless people off the streets, the City of Los Angeles is implementing ~64-square-foot **Tiny Homes** projects scheduled to open in April, 2021 at an average cost of ~\$82,000 per home while similar projects in Riverside, California and other state jurisdictions (Seattle, Washington in particular) with similar shared facilities (bathrooms, showers) have been built at an average cost of less than \$12,000 per home - projects which encourage a sense of community often resulting in self-governance of what's felt to be a small albeit temporary 'village' with residents performing chores; and
- The sense of ownership and security provided by **Tiny Homes** contributes to the mental stability homeless people need to move forward and therefore appeals to and attracts homeless people who feel otherwise alienated by other programs (such as shelters lined with beds in large areas shared with unfamiliar people) while waiting for the construction of the permanent housing upon which such temporary housing projects (including **Bridge Housing**) are legally long-term dependent;

Be it therefore resolved that the VNC Board is requested to adopt the following motion to include the above Whereas clause:

The VNC Board supports the concept of Tiny Homes projects and, in a letter to Los Angeles City Councilmember Mike Bonin, Council District 11, with copies to other Los Angeles Neighborhood Councils, requests that he:

- Research and take whatever steps are necessary to enable the City of Los Angeles to emulate the Riverside, California and Seattle, Washington examples in providing Tiny Homes to homeless people - including Seattle's citizen-driven model (nonprofit enterprises with citizen participation) - to the benefit of the Los Angeles Venice Neighborhood Council area as well as to the benefit of all other Neighborhood Council areas in the City of Los Angeles; and
- Explore the impact of the implementation of such a program on the current federal decisions which permit homeless people to reside with their belongings on neighborhood sidewalks and streets, whether or not in vehicles or tents or their equivalents.

To stimulate the vitality of the VNC, the Board and VNC Committees are encouraged to consider the below <u>VNC Vision Goals</u> in their deliberations.

Although the VNC is a political body, and inevitably it may become embroiled in issues that divide the community, these goals are designed to promote a more proactive, collaborative vision for VNC Committees to include in their deliberations as they formulate recommendations for Board consideration. The intent is to create a working framework of integrated strategies capable of achieving, over time, broader consensus and increased:

Focus on Children

Consider strategies that promote & expand opportunities for children to experience direct meaningful involvement in all aspects of the social and economic and cultural activities of the <u>Venice Community</u>. Include this Focus on Children as an integral part of the consideration of strategies in all of the below Vision Goals.

Participation

Consider strategies that encourage & facilitate broader involvement of stakeholders, major organizations, communitygroups, and government institutions, etc.

Walkability

Consider strategies that reduce the use of cars and that promote alternatives such as walking, skateboarding, biking & bike racks, circulation systems (trolleys), park & ride rather than additional parking, street-narrowing/sidewalk widening, walk/bike/skateboard lanes separated from traffic, easier neighborhood pedestrian access to commercial stores, etc.

Diversity

Consider strategies that encourage & facilitate realistic recommendations designed to increase economic diversity, including affordable housing, etc

Creativity

Consider strategies that promote the arts, encourage & facilitate creativity. This can apply to architecture, public art, social events (neighborhood gatherings/street movies/theatre/dance/pottery/...), etc.

Collaboration

Consider strategies that encourage& facilitate 'level playing fields' for collaborative negotiation; opt for procedures & policies that 'promote flexibility & dialogue' over 'reacting defensively to rigid criteria', facilitation/mediation training, etc.

Brainstorming

Consider strategies that encourage & facilitate exploring of non-traditional options for achieving shared objectives, etc.

Please note that under the Brown Act, the Discussion Forum Committee is prevented from acting on a matter that you bring to its attention during the General Public Comment period; however, the issue raised by a member of the public may become the subject of a future Discussion Forum Committee meeting. Public comment is limited to 2 minutes per speaker, unless adjusted by the presiding officer.
