**13E Resolution to Require Fire Safety Buffer between Encampments and Structures** (Soledad Ursua on behalf of the Public Health & Safety Committee)

Whereas, Venice has witnessed numerous fires over recent years in homeless encampments, in recreational vehicles, and free-standing fires in public; and

Whereas, these random and ongoing fires pose a tremendous threat of serious lifelong injuries or potential death to our Unsheltered population; and

Whereas, the recent fire at 723 Ocean Front Walk (OFW) destroyed the office building at that location and threatened nearby apartment buildings and single-family residences; and

Whereas, the Los Angeles Fire Department has announced that the fire at 723 OFW spread from the large homeless encampment on Park Avenue adjacent to the building; and

Whereas, fires on Rose Avenue next to Penmar Golf Course have threatened the golf course's expansive tree canopy and resulted in the city removing all encampments on Rose Avenue east of Lincoln Boulevard, setting a positive precedence for addressing fire danger in Venice; and

Whereas, Venice has an unusually high percentage of wooden and historic structures that are especially vulnerable to fire; and

Whereas, such a buffer zone would significantly advance the objective of protecting residences and other structures from fire; and

Whereas, there is precedence in the City of Los Angeles banning camping in other fire-vulnerable areas, such as the bluffs along Pacific Coast Highway in the Pacific Palisades; now

Therefore, be it resolved, that the Venice Neighborhood Council calls upon the Los Angeles City Council to immediately pass an ordinance to reinforce and enhance current LA City Fire Code by; prohibiting tents and/or temporary flammable structures to be located within 20 feet of lot lines, buildings, other tent or membrane structures, parked vehicles or internal combustion engines; banning any fires for any purpose on public property within 50 feet of any structure; banning flammable-liquid-fueled equipment use in tents or membrane structures; requiring flammable and combustible liquids shall be stored per LA Fire Code not less than 50 feet away from lot lines, buildings, other tent or membrane structures, and parked vehicles; and ensure all fire access lanes are clear for emergency use. The Venice Neighborhood Council further calls upon the Los Angeles Fire Department to conduct an immediate study of the fire hazard posed to structures in Venice by encampments and to issue orders for those encampments that pose a fire threat to be removed from proximity to those structures and fire access lanes.

• Under pressure from a federal lawsuit to get homeless people off the streets, the City of Los Angeles is implementing ~64-square-foot <u>Tiny Homes</u> projects scheduled to open in April, 2021 at an average cost of ~\$82,000 per home while similar projects in Riverside, California and other state jurisdictions (Seattle, Washington in particular) with similar

shared facilities (bathrooms, showers) have been built at an average cost of less than \$12,000 per home - projects which encourage a sense of community often resulting in self-governance of what's felt to be a small albeit temporary 'village' with residents performing chores; and

• The sense of ownership and security provided by <u>Tiny Homes</u> contributes to the mental stability homeless people need to move forward and therefore appeals to and attracts homeless people who feel otherwise alienated by other programs (such as shelters lined with beds in large areas shared with unfamiliar people) while waiting for the construction of the permanent housing upon which such temporary housing projects (including <u>Bridge Housing</u>) are legally long-term dependent;
