7. ABBOT KINNEY TRAFFIC SLOWING

- **a. Item for Discussion:** Traffic slowing on Abbot Kinney between Venice and Washington.

Possible Motion: Whereas, for months, members of the community living adjacent to Abbot Kinney Blvd, between Venice and Washington Blvd, have urgently reached out to the PTC requesting traffic calming measures, improved bike infrastructure, and a safer crosswalk and a sidewalk at the intersection of Marr St and Abbot Kinney Blvd, the PTC recommends the VNC approves suggestions of safety improvement measures in this corridor, including:
 - **I.** Raising the crosswalk at the intersection of Marr St and Abbot Kinney Blvd.
 - **II.** The filling in of extraneously wide / slip lanes and addition of painted continental crosswalks at the following intersections of Abbot Kinney Blvd, in the following order of priority: Washington Way, Woodlawn Ave., Angelus Pl. and Crestmoore Pl.
 - **III.** The request for a boundary survey on the east side of the Marr St (just south of Abbot Kinney) to study the possible addition of a sidewalk.
 - **IV.** The removal of the center turn lane on Abbot Kinney Blvd between 1708 Abbot Kinney Blvd and Garfield Ave, and the addition of a striped, painted, and buffered unprotected bike lane.

In addition, the PTC recommends that the VNC distribute these suggestions to CD11 and LADOT alongside a CIS.

- **d. Possible Motion:** The PTC recommends VNC takes the following position in regards to the recent adoption of Ordinance 187427 regarding speed limit reductions:
 - **I.** VNC supports the action taken by the LA City Council on March 7, 2022 in passing Council File 21-1223 regarding Speed Limit Reductions.
 - **II.** VNC supports the efforts to reduce the speed limit by 5 MPH on streets that were recently identified for 5 MPH speed limit increases. (See the attached Ordinance number 187427 with the complete list of streets effected.)
 - III. Moving forward, it is the suggestion of VNC that City Council open a Council File to consider that future speed limit reductions be discussed and planned as neighborhood or regional traffic improvements rather than individual street improvements. These improvements should be coupled with measures to minimize vehicle traffic being redirected onto adjacent neighborhood streets. For example, we would like to see LADOT incorporate traffic calming measures and active transportation elements. Traffic calming measures might include compact traffic circles/mini roundabouts, restricted turns, curb extensions/bulb-outs, speed humps and tables, and diagonal diverters, half closures, full closures, and median barriers to reduce cut-through traffic.
 - **IV.** In addition, VNC requests that the Council Offices engage the local Westside Councils in ongoing discussions about what additional streets should be considered for speed limit reductions as well as establish a method whereby Council and stakeholder feedback on this issue can be submitted directly to LADOT.

9. VENICE BLVD. IMPROVEMENTS PROJECT CONCERNS/WITHHOLD SUPPORT

The new Venice Blvd Mobility Improvements project has highlighted the importance of obtaining project-specific data and studies from LADOT and its partners so that all the local and regional impacts of these projects can be identified, discussed and addressed.

Venice Blvd. when the road diet component of this project is installed, our Council will be withholding its support for Phase One of the Venice Blvd Mobility Improvements project.

The member Councils directly affected by this project are: Venice, Mar Vista, Palms and South Robertson. The member Councils which may be affected by redirected traffic include: Del Rey, WLA/Sawtelle and Westside.
