IN CONFORMITY WITH THE SEPTEMBER 16, 2021 ENACTMENT OF CALIFORNIA ASSEMBLY BILL 361 (RIVAS) AND DUE TO CONCERNS OVER COVID-19, THE VENICE NEIGHBORHOOD COUNCIL MEETING WILL BE CONDUCTED ENTIRELY WITH A CALL-IN OPTION OR INTERNET-BASED SERVICE OPTION.

Every person wishing to address the Board must dial telephone number listed above, and enter the above Meeting Id number and then press # to join the meeting. When prompted by the presiding officer, to provide public input at the Neighborhood Council meeting the public will be requested to dial *9 or use the Raise Hand option, to address the Board on any agenda item before the Board takes an action on an item. Comments from the public on agenda items will be heard only when the respective item is being considered. Comments from the public on other matters not appearing on the agenda that are within the Board's jurisdiction will be heard during the General Public Comment period. Please note that under the Brown Act, the Board is prevented from acting on a matter that you bring to its attention during the General Public Comment period; however, the issue raised by a member of the public may become the subject of a future Board meeting. Public comment is limited to 30 seconds per speaker, unless adjusted by the presiding officer of the Board.

AB 361 Updates: Public comment cannot be required to be submitted in advance of the meeting, only real-time public comment is required. If there are any broadcasting interruptions that prevent the public from observing or hearing the meeting, the meeting must be recessed or adjourned. Mobile toilets for sanitary health and safety

MOTION:

In order to assist in helping to maintain, at the most basic level: - The sanitary health and safety of all persons housed and unhoused. - The dignity of the unhoused. - The respect for the housed. Since safe camping areas have yet to be designated, properly maintained and supervised by the City of LA, we feel this solution is the most basic mandatory service required of the City of LA. We ask that the City of LA immediately provide to ensure safety and cleanliness to any encampment of 5 or more tents an adequate supply, maintenance and monitoring of mobile toilets and hand washing facilities made available 24/7. When and if an encampment is dispersed these facilities are to be kept available to be used where ever these encampments reappear. The monitoring and maintaining to be provided by a locally based safety monitoring entity relying on persons inhabiting the encampment.
