Short-Term Vacation Rental Motion

Whereas, short-term vacation rentals are rapidly increasing in Los Angeles as the result of internet-based brokerages listing available dwellings and facilitating rental reservations - one online site lists 746 short-term rentals in Venice; and

Whereas, the demand for short-term rental units has resulted in long-term rental units being withdrawn from the market; and,

Whereas, the City does not regulate the short-term rental market as it does hotels and motels, but the City has a duty to protect both the proprietors of such dwellings and their customers; and

Whereas, the City has an opportunity to add revenues from the licensing of short-term vacation rentals by licensing such rental units, applying taxes to renters and putting in place enforcement personnel to assure such fees and taxes are properly calculated and collected.

Therefore, be it resolved, The Neighborhood Committee of the Venice Neighborhood Council recommends that the Board of the VNC pass the following motion:

Resolved, The Venice Neighborhood Council requests that the Councilperson for the 11th City Council District, Mike Bonin, introduce a motion to the full City Council requesting that the conditions surrounding short-term rental of dwellings in Los Angeles be investigated by appropriate City Departments, that an ordinance be drafted regulating such rentals, that the ordinance be submitted to a vote of the City Council prior to 02/15/2014 and that such ordinance would take effect prior to May 26,2014.

Discussion: Judith Goldman spoke of Vacation Rentals on Dudley between Pacific & Speedway. Six houses that she's identified now vacation rentals and advertised on AirBNB on her block alone. Discussion of regulations – Hotel Tax 19% - but only collected if rentors identify the units they are renting. No one was sure about regulations (our expert, Robin, was out of town!). Jerry says he's seen corporate buyer come in to buy houses for the purpose of vacation rental market – they can make more in that market. Marc is concerned about loss of housing stock. Loss of available units will raise prices, making rentals in Venice less affordable.
