#### MOTIONS PRESENTED

### **MOTION #1**

### Motion to Support City Motion to Create Full-time Office of Reunification

We ask that the Venice Neighborhood Council write a community impact statement letter supporting Councilmember Nury Martinez's motion that the city create a full-time office of reunification that was originally supported through efforts of our own reunification program that was created here in October, 2016.

#### LETTER:

The Venice Neighborhood Council (VNC) requests that the following statement of "Support" be attached to Council File 17-1383: Family Reunification Through Service Providers.

The Venice Neighborhood Council supports "CF 17-1383: Family Reunification Through Service Providers" for the positive impacts that such a coordinated program will have on the homeless population, their families, residents and businesses of the City of Los Angeles and based on the incredible success our pilot program has been in reducing homelessness in Venice and the millions of dollars associated with serving the homeless crisis in the city of Los Angeles.

#### **MOTION #2**

Motion to Support the West LA VA's Master Plan to Provide Housing to Veterans on Their Campus.

We ask that the VNC provide a letter of support for the VA's plan to build housing for homeless veterans on their West LA Campus.

#### MOTION #3

Motion to Request 2018 Jones Settlement report

Whereas the city has yet to present updated stats and figures that show whether or not the terms of the Jones Settlement have been satisfied.

Therefore we request that the VNC requests in writing such information be provided by Councilman Bonin, Mayor Garcetti, Deputy Mayor Christina Miller and LAHSA Director Peter Lynn and to present to the city and up to date accounting on where the city stands to meet Jones Settlement housing threshold. And if the numbers have been met to immediately start enforcing LAMC 51.18 and 41.11.

### **MOTION #4**

### Motion to Support Creation of Safe Camping Program in Venice

Whereas the city of Los Angeles has been handcuffed by the terms of the Jones Settlement to enforce laws that provide safe, clean and clear sidewalks for residents, businesses and visitors.

Whereas the spread of homeless encampments in Venice has been responsible for multiple shootings, stabbings and ongoing criminal behavior including burglaries, auto theft and assaults.

Whereas the terms of the Jones Settlement no longer serve the community in the ways it was intended and the increase of homeless living on the streets of Venice has been untenable.

Whereas the lack of enforcement of LAMC 41.18 and 56.11 has invited drifters and travelers from outside the city and state of California to camp on our streets and exploit the services and goodwill intended to assist the most vulnerable of our city.

Whereas we need a solution that better serves both the housed and un-housed in our community and provides a safe and clean environment for all.

Therefore we ask that the city create a "Safe Camping" pilot program that provides safe locations for only those individuals who are seeking housing, employment and assistance to get off the street and are registered in LAHSA's Coordinated Entry System (CES) and provide all people registered with a specific and reserved spot on a designated sidewalk only between the hours of 9pm and 6am and enforce the terms of all laws between the hours of 6am and 9pm to keep streets and sidewalks clear. We also request that the neighbors have the opportunity to approve each location on their block with a 2/3rds majority.

Whereas the city of Los Angeles has created a program to allow homeowners to build structures in their backyards to house homeless individuals.
