Whereas, the population in the Los Angeles Metropolitan Statistical Area has increased by 100% in the past 60 years and the zoned population capacity of the largest city (second largest city in the US) in that statistical area, the City of LA, has decreased by 60% in the past 60 years; and

Whereas, there is a direct correlation between the availability of housing and homelessness; and

Whereas, the SCAG (Southern California Association of Governments) RHNA (Regional Housing Needs Assessment) housing allocation numbers are tasking the City of LA to increase its housing by 455,565 units by 2029 which represents a 33% increase in housing in 8 years; and

Whereas, the City of LA has not chosen to appeal this requirement;

Therefore, the following motion is made:

The Venice Neighborhood Council requests our Councilman Mike Bonin, our Mayor Eric Garcetti and/or the LA City Planning Department to report to us no later than 3Q 2021 the how, where, and when this additional housing will be accomplished, and why that particular distribution of units was selected.
