Whereas the City of Los Angeles has entered into a legal settlement of the case Willits v City of Los Angeles and;

Whereas under the terms of this settlement, the City has taken many steps to bring all sidewalks into compliance with ADA regulations and;

Whereas such compliance can often require the removal of trees therefore:

The Neighborhood Committee proposes that the Venice NC Board recommend to Councilman Mike Bonin, the Department of Public Works, the Bureau of Street Services, the Department of Recreation and Parks and the Urban Forestry Division that:

In the case of any tree removal, the City of Los Angeles provide more than 72 hours notification of said removal and:

Such notification be made in writing to property owners within a 500 ft radius and;

Trees designated to be re-planted MUST be replanted in the Neighborhood Council area in which said tree was originally planted and;

More information about alternatives to tree removal regarding the sidewalk repair program be codified and provided to any applicant submitting for a tree removal for any reason.
