Whereas, on May 17, 2017, the VNC passed a MOTION supporting the submissions of applications for People St Plaza Projects on Venice streets between Ocean Front Walk (OFW) and Speedway, subject to VNC final approval;

Whereas, the Venice Neighborhood Council (VNC) supports public outreach and input on People St Projects:

Therefor, be it resolved, the Venice Neighborhood Council (VNC) recommends that an independent traffic study be undertaken by any applicant of People St Plaza Projects in Venice to determine the impacts of any proposed project on transportation systems in the surrounding community and further directs the Ocean Front Walk (OFW) Committee of the VNC to consider any pending or proposed application for a People St Plaza Project on any street between OFW

and Speedway at a properly noticed meeting with outreach to applicable street residents and businesses and the surrounding community prior to the VNC final approval of any People St Plaza Project.
