A. Opposition Use of the Westminster Senior Center for Storage. (Mark Ryavec)

MOTION: Whereas, the Councilman of Los Angeles City Council District 11 has introduced a Motion (CF 15-1138 S-8) to convert the Westminster Senior Center at 1234 Pacific Avenue for use as storage for the possessions of persons who are homeless; and

Whereas, this facility is in a public park, and adjacent to an elementary school and scores of residences; and

Whereas, the majority of the residents residing near this facility are opposed to this use; and Whereas, many parents of children attending Westminster Elementary School are also opposed to this use; and

Whereas, there have been no public hearings on this conversion; and

Whereas, the City of Los Angeles is legally prohibited from this use of the property by a a restriction to the property's deed recorded by the Los Angeles Superior Court on July 5, 1950, which limits the use to public playground and recreation uses, and

Whereas, the proposed use is illegal under recently adopted amendments to Los Angeles Municipal Code 63.44, which state at B. 26 (f):

Removal of Stored Personal Property; Discarding of Stored Personal Property.

- (1) No Person shall Store Personal Property in any Park.
- (2) All Stored Personal Property remaining in any Park after closing may be removed by the City. and,

Whereas, the use of a large storage container at the Venice Beach Paddle Tennis Courts has proved the efficacy of using such a container for storage use; and

Whereas, several other options exist for storage which will not impact a neighborhood park, an elementary school and adjacent residents, including the former MTA bus yard, which could be rented by a non-profit such as Chrysalis and out-fitted with containers, and private storage facilities, e.g. Stor It Self Storage at 4068 Del Rey Ave, Marina Del Rey, CA 90292, which is located next to industrial and commercial uses, not a school, park and residences; and Whereas, enforcement of the new versions of LAMC 63.44 (prohibition of storage in parks) and LAMC 56.11 (limits on storage on sidewalks) will necessitate City storage for abandoned property, prohibited bulky items, and illegally stored property; now

Therefore, be it resolved, that the Venice Neighborhood Council opposes the use of the Westminster Senior Center at 1234 Pacific Avenue for use as storage; and Further, the Venice Neighborhood Council calls upon the Councilman of District 11 to secure storage facilities at least 300 feet from any residences or parks for the proposed storage use identified in CF 15-1138 S8 and for abandoned and other property acquired by the City under LAMC 56.11 and LAMC 63.44 and when operational to relocate the stored items at the Venice Beach Paddle Tennis Courts to the new location to remove them from proximity to residences and their location in park, which now violates LAMC 63.44.

B. Adhere to Oxford Triangle Neighborhood Study for Future Use of Thatcher Yard (Steve Freedman)

MOTION: Whereas, the City-owned Thatcher Yard operated in the heart of the Oxford Triangle for decades; and

Whereas, even at full capacity the Yard was only open about 50 hours per week and was closed every night, weekends, and holidays; and

Whereas, City operations on the Yard were a minimal generator of noise and traffic; and Whereas, any residential development on the site will generate far more traffic throughout the day and night through the Oxford Triangle neighborhood than city operations did; and Whereas, in 1988 Oxford Triangle residents participated in the Oxford Triangle Neighborhood Study as part of the Venice Neighborhood Study Presentation Workshop, which was sponsored by the District Council Office and City Planning Department and contributed to Development Standards and the Local Coastal Program for Venice; and

Whereas, the Oxford Triangle Neighborhood Study was completed and presented on November 5, 1988, and states under Zoning preferences that: 'The City Maintenance Yard and other City owned lots must be zoned for single-family homes if the City decided to abandon operations at the site (Section 1, on Page 10, Item 16); and

Whereas, the industrial property at the southeast end of the Oxford Triangle was rezoned C4-OX-2D in the 1980s to allow high-density residential development, approximately 1800 units of condominiums and apartments in six high rise developments were built on that property since that time, which increased the density of the Oxford Triangle five fold; and

Whereas, in 2010 the City of Los Angeles held a series of public meetings to advise the community of its plans for the Thatcher Yard and take public input, and at that time City representatives stated that the City intended to demolish the existing structures and replace them with new structures, which would allow the City to resume maintenance operations from the site; and

Whereas, it will be difficult for the City to acquire additional Westside property of a similar size or to rezone such property due to community opposition for use by City departments for maintenance operations in Venice and adjoining City districts such as Mar Vista and Del Rey; and

Whereas, the proposed 2016-17 City budget identifies the Yard for either sale (with the proceeds going to fund homeless housing) or for development of homeless serving housing at the Yard; and

Whereas, the City has taken steps to pre-qualify developers to bid to build high density apartments to house the homeless on this site in contradiction to the 1988 Neighborhood Study's commitment to single family residential zoning; and

Whereas, there have been no public hearings in Venice or by the Venice Neighborhood Council on the proposal to use the Yard for homeless housing or to sell it to generate funds to build homeless housing elsewhere; and
