The VNC urges LADWP and the City to maintain FiT energy buy-back prices at a level sufficient to encourage participation in the program, to be mindful of market prices and also, to expand FIT from its current 150 megawatts to 1200 megawatts.

Therefore the Venice Neighborhood Council supports the green concept of turning the airport property into a grand park to serve all of the entire area, a use that would not increase traffic and would be environmentally healthful to all and would provide badly needed open space in an are that has very little. Many Santa Monica residents and organizations, as well as the Mar Vista Neighborhood Council and the Sierra Club have supported this concept.

Venice is a neighbor of this property on the south and west boundaries. A grand park, approximately one third the size of Central Park would have multiple recreational uses. Walking and cycling paths as well as natural habitats and plants could turn this pollution creating area into a green oasis in the midst of our dense urban communities. The park could serve as an arts and performance center for the area, picnic areas as well as park related business. The vision is just beginning and the VNC to support it.
