12D Scooter Enforcement and Guidelines Pertaining to OFW & Bike Path (Colleen Saro, colleen.saro@venicenc.org)

**MOTION:** Whereas, the Venice Boardwalk is limited to pedestrians, with the exception of ADA compliance, and

Whereas, the Venice Bike Path is limited to bikes, and

Whereas, there is a need for the LAPD to enforce the abundance of Scooters (BIRD, LIME and other misc. scooters) in addition to any electrical and gas powered vehicles, which are now being used on the Boardwalk and the Bike Path illegally causing safety and littering issues, and

Whereas, the Scooters are being left in the sand, off the Bike Path, and scattered along the Boardwalk, which is becoming a littering and nuisance issue, and

Whereas, the Scooters and other electrical and gas powered vehicles are making it unsafe for pedestrians on the Boardwalk and for bikes on the Bike Path

Therefore, the Venice Neighborhood Council (VNC) recommends to the La City Council's Transportation and Public Safety Committees, Councilman Mike Bonin, Council President Herb Wesson, LA County Supervisor

Sheila Kuehl, State Senator Ben Allen and State Assemblywoman Autumn Burke to:

- 1) create a mandate for an ordinance that all Scooters and electrical and gas powered vehicles have a Geo Fence installed so that they will be disabled if they go west of Pacific, thus keeping them off the Boardwalk and Bike Path.
- 2) create a Geo Fence so that a helmet needs to be within a 4' distance from the scooters, or else it will be disabled.
- 3) create nesting /docking areas stationed at specific locations, like the Hulu and City Bikes, so they are not inconveniencing residents, blocking sidewalks and creating litter. As of now LAMC 56.11 is not being enforced.
- 4) create rules and limitations and post them on the handlebars, or the box (ride anywhere) mounted on the handlebars where the rider has to sign in.
- 5) create a weight lock so that once a person steps on the Scooter, the initial weight will be registered, and if more weight is added, (by an additional person being on the Scooter), the Scooter would then be disabled.
