The internship program would promote the uniting of interested young people with organizations where they could serve for a period of time. Any actual DFC/VNC activities directed at encouraging internships would be approved by the VNC Board in subsequent motions, upon DFC's presentation of further information regarding potential partners to the DFC in these efforts, appropriate eligibility requirements for interns (ie age range, etc.), any relevant guidelines and regulations, and appropriate measures for limiting potential liability.
