The motion that was voted on reads: Whereas there is overwhelming evidence that Pacific Ave is a hazard to pedestrians and drivers alike; and whereas there is a public need and necessity to correct the current situation,

Therefore be it resolved that the VNC send a letter to LADOT and CD11 requesting the following:

1. Immediate traffic enforcement
2. Immediate parking 24/2 (weekends) in both directions to help create a safety buffer for pedestrians. Furthermore, the VNC recommends that parking restrictions on Pacific Ave., from the Santa Monica border to Windward Ave., be removed on weekends starting at 8:00 PM on Friday evening and ending at 8am on Monday morning. Recommended by Parking And Transportation Committee 6,0,0 on 2-6-18

**14B Amendments To VNC Bylaws** (John Reed on behalf of the Rules & Selections Committee)

**MOTION:** The VNC Board approves the following amendments to the VNC Bylaws (requires an affirmative vote of  $\frac{2}{3}$  of the Board members present and voting):

**Article IV Section A:** "Stakeholders" are defined as ~~Non-Community Interest~~ **Vested** Stakeholders and Community Interest Stakeholders.

1. ~~Non-Community Interest~~ **Vested** Stakeholders are defined as individuals who live, work, or own real property within the VNC boundaries.

**Article V Section 9:** The Board may remove any Officer whenever the best interests of the VNC would be served. No Officer shall be removed for any arbitrary, capricious or discriminatory

reason. Removal of a Board Officer requires a three-quarters (~~3/4~~) **2/3** vote of the Board Officers present and voting at a meeting.

Recall: Recall is the procedure by which stakeholders may initiate the removal of an elected Officer. Any stakeholder may put forth a Recall petition by presenting a petition to the Secretary with no less than two hundred (200) signatures of **Vested** stakeholders supporting the motion.

**Article VII Section 1A:** Administrative Committee: Consists of eight (8) Officers, including the President, Vice-President, Secretary, Treasurer, and four (4) Community Officers who shall be selected by the fourteen (14) Community Officers at the first Board of Officers meeting. Chaired by President. Sets agenda for Board of Officers and ~~Stakeholder~~ **Town Hall** meetings.

**Article X Section 2 B:** Community Officers:

1. Thirteen (13) Community Officers are elected at-large by the ~~non-community interest~~ **Vested** Stakeholders.

2. One (1) Community Interest Community Officer is elected by ~~all~~ **the Community Interest** Stakeholders.

3. Only Community Interest Stakeholders shall be entitled to run for the one (1) Community Interest Community Officer and may not run for any of the other elected Seats.

**Attachment B: Who may vote for Community Interest Candidates:**

~~All Stakeholder 16 years or older~~ **Stakeholders who do not live, work or own real property within the VNC boundaries who are 16 years or older and who affirm a substantial and ongoing participation within the Neighborhood Council's boundaries and who may be in a community organization such as, but not limited to, educational, nonprofit and/or religious**
