6:00 Discussion of possible initiatives related to assisting children's educational and social growth during the pandemic, as summarized at our August 3, 2020 meeting:

The discussion raised a variety of topics related to the impact of the pandemic on the education of children – including the need for teacher-student bonding and peer-to-peer socialization – and how to achieve these twin objectives in the context of the <u>Family Friendly Streets Initiative</u>, particularly for K-5 children, in a way that could be a model for use effectively in all residential neighborhoods.

Among the ideas discussed was the possibility of using designated <u>Family Friendly Streets</u> for education pods (teacher-student bonding) and play/artwork areas (peer-to-peer socialization).

There was considerable skepticism about whether the <u>Family Friendly Streets Initiative</u> could be used to achieve this twin objective.

Other ideas were aired. One was to use parking lots or walk streets for these purposes. Another was the problems involved with reliance on webinars instead of in-school classes – issues then under discussion between school administrators, unions, and teachers and parents – and various hybrid options also came up.

There was no clear resolution of the matters raised except a clear interest in doing things which could help achieve the twin objectives via a model that could be emulated in all residential neighborhoods.

To stimulate the vitality of the VNC, the Board and VNC Committees are encouraged to consider the below <u>VNC Vision Goals</u> in their deliberations.

Although the VNC is a political body, and inevitably it may become embroiled in issues that divide the community, these goals are designed to promote a more proactive, collaborative vision for VNC Committees to include in their deliberations as they formulate recommendations for Board consideration. The <u>intent</u> is to create a working framework of integrated strategies capable of achieving, over time, broader consensus and increased:

Focus on Children

Consider strategies that promote & expand opportunities for children to experience direct meaningful involvement in all aspects of the social and economic and cultural activities of the <u>Venice Community</u>. Include this Focus on Children as an integral part of the consideration of strategies in all of the below <u>Vision Goals</u>.

Participation

Consider strategiesthat encourage & facilitate broader involvement of stakeholders, major organizations, communitygroups, and government institutions, etc.

Walkability

Consider strategiesthat reduce the use of cars and that promote alternatives such as walking, skateboarding, biking & bike racks, circulation systems (trolleys), park & ride rather than additional parking, street-narrowing/sidewalk widening, walk/bike/skateboard lanes separated from traffic, easier neighborhood pedestrian access to commercial stores, etc.

Diversity

Consider strategies that encourage & facilitate realistic recommendations designed to increase economic diversity, including affordable housing, etc

Creativity

Consider strategiesthat promote the arts, encourage & facilitate creativity. This can apply to architecture, public art, social events (neighborhood gatherings/street movies/theatre/dance/pottery/...), etc.

Collaboration

Consider strategiesthat encourage& facilitate 'level playing fields' for collaborative negotiation;opt for procedures & policies that 'promote flexibility & dialogue' over 'reacting defensively to rigid criteria', facilitation/mediationtraining, etc.

Brainstorming

Consider strategies that encourage & facilitate exploring of non-traditional options for achieving shared objectives, etc.

Comments from the public on agenda items will be heard only when the respective item is being considered. Comments from the public on other matters not appearing on the agenda that are within the Discussion Forum Committee's jurisdiction will be heard during the General Public Comment period. Please note that under the Brown Act, the Discussion Forum Committee is prevented from acting on a matter that you bring to its attention during the General Public Comment period; however, the issue raised by a member of the public may become the subject of a future Discussion Forum Committee meeting. Public comment is limited to 2 minutes per speaker, unless adjusted by the presiding officer.
