**MOTIONS** - **MOTION**: Whereas State Assembly bill 672 is on the Assembly agenda for early in 2022 and whereas this bill would effectively remove the protections of the Public Park Preservation Act from all public golf courses in the State of California, opening them to development and setting a dangerous precedent for other parks and whereas Penmar Golf Course would be one of these courses, therefore the Venice Arbor Committee asks that the VNC write a letter to Mayor Garcetti requesting that, in the best interest of its citizenry and to preserve the protections of all recreational parks in the City, a letter be written by him to Assemblywoman Autumn Burke, requesting that she vote against this bill.

The bill should be attached in supporting documents and perhaps the SCGA article attached as well.

MOTION: Whereas Mayor Garcetti has instigated a Green New Deal for Los Angeles involving the pla	nting of 90,000
trees by the end of 2021 and whereas this has been deemed a priority in insuring the City's continued hab	oitability and
health and whereas Venice continues to lose tree canopy due to indifferent land use approvals for new co	nstruction and
development, the Venice Arbor Committee requests that the VNC send a letter to	and
insisting that the City use the simple, one page, Tree Disclosure Statement no	w successfully in
use by the City of Palo Alto for all future development in the City of Los Angeles starting immediately.	

- 7. Items for Discussion, Action, and Possible Motion Overarching Goals of VAC:
  - a. Proposal Bird's Eye View to create a Green Coastal Corridor map to show the green areas and the potential green areas of the entire Coastal Area, comprising the Santa Monica Mountains down to Ballona Wetlands. Goal is to create green pathways for wildlife to utilize

and in effect also create greater urban canopy throughout. Isabelle to elaborate. I need to send the map of ballona wetland that Isabelle did as an example. Isabelle explains her work on the ballona map. Noel feels that trees need to be the focus to stay on in this mapping exercise. Barry – missed opportunity the area that includes Penmar, marine park, linked in some way – tree planting to be coordinated – its an existing green area that could be enhanced. There is an unfortunate state bill – SB – they want to remove the parks protection and funding for golf courses so that municipalities can convert to housing. AB 672 look at the golf association. Isabelle thinks we need to find out more information.

b. Start locally with parkways – planting and point to a success – Robin thinks that the parking lot project is a very important – and in the parkways – we should be able to point – Robin has trailer. Michael – Christina Garcia, assembly woman, introduced the AB 672. Robin thinks soooo wrong – we need the green space. Councilmember – need to adamantly oppose getting rid of open space. Need to unified in that voice. Michael will find out the status of AB 672 – how realistic is it that this will pass? Michael will check with his lobbyist. We need to go to our assemblywoman – Autumn Burke.

Isabelle adding – Verdant Venice Group – two groups in Mar Vista – Mar Vista Arbor Group, Mar vista Westdale Group.

Big Concept – need to do a bigger picture so that in certain areas, we plant a more riparian tree, plant trees that are not necessarily on the city list.

Kate – community plan is a big wishlist. Does have a whole design land use element. These things require landscaping on parking lots etc. but there's no accountability.

Barry – proposal – Rachel working on it – requirement to plant a tree in the parkway. Low hanging fruit.

- **c.** Large open paved areas Whole Foods, Ralphs, and other large areas would be incorporated into the above overarching plan. Noel to report on her activities.
- **d.** Education of Public regarding trees website, signage, outreach to all communities to enlist in caring for trees over a long, dry, summer.

Protection of private property trees legislation based on either Palo Alto tree disclosure form requires that they swearing good tool on permit and on plans. or Pasadena up to the city council offices? Robin suggesting that each developer, before LUPC must come to tree committee first before they can get their project through, disclosure form, must come to us before going to LUPC. Whomever is the new chair should probably support. She supports the disclosure form that shows on the plans on the property plans. A member staff reports are very meager. First hurdle would to require the disclosure as part of the staff report.
