1. Call to Order and Roll Call

- 2. Approved Agenda. Isabelle Duvivier moved to approve, Noel Johnston seconded.
- 3. Approved Minutes from prior meeting, October 22, 2021. Sarah Wauters moved to approve, Barry Campion seconded.
- 4. Chair Report Isabelle Duvivier reported on Community Forest Advisory Committee (CFAC), Build Around Trees activities. Looking for Krekorian to get all departments to comply with the biodiversity ordinance. CFAC met with the Planning Department about the requirement that 1 tree is planted for every 4 units. Rachel Malevich gave a report and it appears that there is no clear friend to trees in any of the council district offices. Isabelle is looking at projects that come before LUPC to help with the location of trees. In many cases they are putting them on the roof or over the parking structure, which is not going to grow sufficiently large trees. CFAC will try to get the ordinance changed so that trees can only be planted in the ground. Planning department is looking at making the planter boxes 4' or greater. Most 3' x 5' LID boxes (low impact development) can only collect about 3'/4" of rain. There is a need to get to all the neighborhood councils and elevate the biodiversity mission along the Expo line. This means there is a need to get those of us interested in this area to go to other Neighborhood Council meetings and committees. During the ensuing discussion, many members and public had suggestions. One member of the public asked: Why don't we draft a motion and take it to WRAC regarding the present practice of planting trees on the roof or in boxes to fulfill the tree requirements for new buildings? IS states that a lawyer is drafting a motion.
- 5. **Chair Report -** SW on non-agenda items No items to report.
- 6. **VVG Report –** Watering has proceeded. Announced that Agroperm removal last day would be the following Saturday.
- 7. **PUBLIC COMMENT –** 3 minutes on non-agendized items. Robin Murez asked everyone to oppose the building of the "monster" on December 1st, 2021.

8. Items for Discussion, Action, and Possible Motion

NEW BUSINESS

- a. Venice Arbor Group update on Venice Blvd tree care and planting, mulching and irrigation –
 Request for volunteers Noel gave us report on progress and plans for mulching and
 planting.
- b. Tree well expansion locations and funding Mark R. 1.2 billion dollars to replace 100s miles of sidewalks the city is willing to provide / reconfigure the tree wells. They did so on Windward and by the US post office. Mark suggested that we should bring a list to the city. These locations were mentioned: Venice Way, Grand Ave., Main Street across from the dog park, east side of the street. ID wants the tree wells to be that are empty to be expanded so that a better tree could be planted. Is it cheaper if we do the cutting and planting ourselves? When members / public look for empty tree wells to put on the list with the city, look for:
 - i. Empty trees wells, or obviously filled in ones (sometimes have concrete)
 - ii. Remaining sidewalk needs to be a minimum of 3' wide.
 - iii. High Traffic areas important to the city
 - iv. Minimum total sidewalk of 8'
 - v. This requires us to see if Stephen Dupre will approve a 3' sidewalk.
- c. Penmar golf course presentation and update Barry.
 - i. Penmar goal is to unify the different groups involved.
 - ii. To look at the Westwood greenway that was created near the train station
 - iii. Introduce bioswale to discourage camping and design to have rock in the bioswales.
 - iv. Robin suggests going to Joe Halper, of RAP because they have more autonomy. Go to top.
 - v. Public Works still holds the land
 - vi. Boise v. Martin camping case still applies
 - vii. EVNA Having a meeting on Dec 16th
