Using the eight (8) existing neighborhoods defined in the Venice Specific Plan plus the additional neighborhood east of Lincoln Boulevard as a guide, the Committee shall consist of, at a minimum, nine twelve (9)(12) Stakeholders, one (1) from each neighborhood identified below, plus the Chair. The twelve (9)(12) Neighborhood Committee members shall be elected by the Board of Officers from a list of candidates who have formally communicated to the Board their desire to serve on the Neighborhood Committee. The Board shall, within thirty (30) days after beginning their term, hold a Board of Officers meeting for the election of Neighborhood Committee members. The candidate with the highest vote totals in each of the twelve (9)(12) districts shall be elected. Other neighborhoods and/or Stakeholders representing other neighborhoods or neighborhood interests may then be added at the discretion of the Neighborhood Committee. The committee shall promote greater awareness of available City resources and services and act as a conduit between the Board and Venice neighborhoods, assisting in community outreach and bringing neighborhood issues to the attention of the Board. Committee members selected by the Board may be removed by a majority vote of the full Board.

- 1. Marina Peninsula (bounded by Washington to the North, the beach to the West, the channel to the South, and Grand Canal/Ballona Lagoon to the East).
- 2. Silver Strand (bounded by Washington to the North, the Grand Canal/Ballona Lagoon to the West, the channel to the South, and via Marina to the East).
- 3. Oxford Triangle (bounded by Washington to the North, Admiralty Way (to the extent the properties are in Venice) to the West, Ralph's/4363 Lincoln to the South, and Lincoln Boulevard to the East).
- 4. Canals (bounded by Venice Boulevard to the North, Strongs Drive to the West, Washington Boulevard to the South, and Ocean Avenue to the East).
- 5. Silver Triangle (bounded by Abbot Kinney to the North/East, Ocean Avenue to the West, and Washington Boulevard to the South/East).

- 6. President's Row (bounded by Venice Boulevard to the North, Abbot Kinney to the West, Washington Boulevard to the South, and Lincoln Boulevard to the East)
- 7. Milwood (bounded by California Avenue to the North, Abbot Kinney to the West, Venice Boulevard to the South, and Lincoln Boulevard to the East).
- 8. Oakwood (bounded by Rose Avenue to the North, Main to the West, Abbot Kinney /to the South, and Lincoln Boulevard to the East).
- 9. North of Rose (bounded by Santa Monica to the North, Main to the West, California Avenue to the South, and Lincoln Boulevard to the East).
- 10. East Venice (all of Venice east of Lincoln)
- 11. Beach Streets North (bounded by Santa Monica to the North, OFW to the West, Windward to the South, and Abbot Kinney to the East).
- 12. Beach Streets South (bounded by Windward to the North, OFW to the West, Washington to the South, and Abbot Kinney to the East).
