Subject: Community Assistance Parking Program (CAPP)

WHEREAS:

- there is a growing population of Venice residents making long-term use of vehicle dwelling as their solution for housing, and, in some instances, this population represents a less visible sub-

group of unhoused in Venice, and may have less contact with aid and service agencies, - in addressing the precarious nature of this type of shelter solution, a major jeopardy is vehicles being towed by the city due to parking tickets or registration issues.

- the (CAPP) is a solution currently available where, in limited circumstances, a program of community service in lieu of fines is available to neighbors who qualify.

- there is currently limited Westside service providers with whom community service hours can be completed, even though many service providers have operations in the West Side.

MOTION:

Let it be resolved that the VNC request of CD11 that service providers such as St. Joseph's, S.P.Y., A Bridge Home, OPCC, The Circle Team, and etc.to explore the viability of becoming a community service to neighbors who seek to use CAPP.

If members of the public are unable to provide public comment or be heard due to issues within the Neighborhood Council's control, the meeting must be recessed or adjourned.

Notice to Paid Representatives -

If you are compensated to monitor, attend, or speak at this meeting, City law may require you to register as a lobbyist and report your activity. See Los Angeles Municipal Code Section 48.01 et seq.
