## 9. UNDER-GROUNDING UTILITIES ON LINCOLN BLVD THROUGH DEVELOPMENT IMPACT FEES

**a. Item for Discussion:** Housing and development is just starting on Lincoln Blvd. Density bonuses, state mandates and incentives will accelerate this transition.

The community has been asking for decades and the city has a great opportunity to push for the ungrounding on these un-sightly utility poles that stretch along the Los Angeles City portion of Lincoln Blvd. This would be instrumental in creating more walkable sidewalks and removing visual blight.

Most importantly, it would allow for large and beneficial trees to be planted. This would help with cleaning the air, diminishing traffic noise, be a home to wildlife, and greatly reduce concrete surface temperatures.
