1) Please explain why you wish to serve on LUPC.

My family built and has owned apartments here for over 40 years. I've lived in Venice and in other parts of LA. I've seen development that is good, that appreciates the growing needs of our population, and I've seen some that doesn't. We're at an important point in Land Use planning for Venice, with State and local pressures and the new Community and Coastal Plans to be developed. My professional experience in land use and my personal familiarity and care for Venice, can help bring about better decisions for the community.

2) Please state your professional qualifications or related life experience relevant to serving on LUPC.

My work is as a industrial / commercial broker in the Valley. I've built projects ground up, from design through permitting and construction. I've dealt with lot splits, parcel maps, off site dedications, plan check... It isn't an easy process but having done it, I've learned a great deal about what works and what doesn't. What is appropriate to a site and the community, and what should be modified. That experience will enable me to evaluate projects being brought to LUPC as well as to give constructive input into the development of the new Community Plan.

I don't see the time commitment as a problem. I'm an empty nester; my daughter is in college, so after school activities aren't taking up my time. I work 9 to 5 but with flexibility. I'm active but organized and stay on top of commitments. Serving on LUPC would be a top priority. My experience with property matters will enable me to evaluate and draft staff reports more readily than might be true for others with less experience.

4) Please list your previous and/or current neighborhood or community involvement.

Assisting in managing our family apartment buildings on Ocean Front Walk particularly navigating these recent years, has given me, like most Venetians, a new level of neighborhood and community involvement.

I've been concerned by the lack of transparency by City and County decision makers as well as pressures and legislation being imposed by State lawmakers.

Specifically, I am opposed to the proposed Venice Dell Project for numerous reasons including its failure to comply with CEQA, zoning, mass, traffic, road safety, open space needs present and future environmental issues that affect our unique coastal community and access for all to the

beach. Transparency, outreach, evaluations and legal procedures should not be skirted in the name of increased housing density nor for any reason.

Having served on the VNC Preserving Public Places Committee, I've seen the power the VNC can have when we join together to better the community. By researching, analyzing and exposing the controlling documents, we prevented County's proposed (exorbitantly expensive) demolition of the Venice Lifeguard Station tower, as the Venice community overwhelmingly supports.

Repurposing existing buildings also looks to be a far for efficient means to realize housing goals.

5) Please list the most critical planning and land use issues you feel are facing the Venice Community.

Developing the new Venice Community and Coastal Development Plans will have far reaching implications for the liveability, bikeablity, walkability, affordability, safety and enjoyment of all Venetians. We may need to challenge State or City assumptions where they do not reflect Venice's realities or interests and propose better solutions.

Additionally, the ongoing work of LUPC of evaluating the suitability of projects, encouraging outreach dialogues with neighbors, interfacing with the VNC Board and Planning Department is crucial to realizing development that is good for the community.
