The VNC Outreach Officer position feels like a natural fit for me. I thrive on connecting with others and being of service. I already “outreach” to neighbors/stakeholders and represent them at their request, assisting them with resources to get their needs met. My experience is that many stakeholders are unaware of the VNC and it’s function. I would love change that by bringing visibility and access to stakeholders by having a presence at community events and utilizing social media as well.

a) Have you served before on the VNC Board or other Neighborhood Council Board? If so, where and when? NO, However, I was recently elected to the VNC Board as an At Large Community Officer and have subsequently was sworn in less than 1 month ago.

b) Have you served on a VNC Committee? Which one and for how long? YES

The Venice Community Resiliency Committee (VCRC) which I have enjoyed immensely for almost 2 years.

My profession for the past 38+ years is that of being a Sole Proprietor of an Event Planning and Catering Company. My credentials are deep and my client list highly recognizable. I am a hands on owner/operator and have produced events with up to 3,000 guests. Over the years I have taken my small company in many directions and have reinvented it to accommodate changes in my industry. Currently I am serving 1,000 person daily via Meals on Wheels and the Homeless via Grace Community Church in Culver City.

Previous to COVID I was catering hot lunches to private schools where my expertise and detailed style was utilized in distribution to include creating coding and a complex website. I am great at building a team and inspiring others to become involved and take action.

I started renting as a resident in multiple areas in Venice to include the Venice Canals on Linnie, Paloma and Speedway, Venice Boulevard next to my business and East Venice next to Penmar Park. I also have been in business in the same location on Venice Boulevard and Glencoe for 38+ years.
