Whereas: In order to successfully respond and recover from emergencies/disasters stemming from these hazards Venice as a community must become Disaster Resilient. Be it Resolved that The Venice Neighborhood Council support the 2024 Disaster Resilient Venice Program initially consisting of an All Hazard Disaster Resiliency Town Hall in January 2024 and a Community Emergency Response Team Training beginning in February 2924 or as soon as practicable.
