# 1) MOTION TO ENSURE THE BOLLARDS AT VENICE BEACH ARE OPERATIONAL AND SERVE AS A DETERRENT TO PASSENGER VEHICLES ON OFW

WHEREAS, the bollards at Oceanfront Walk at Venice Beach were installed to prevent passenger and unauthorized commercial vehicles along the boardwalk, and

WHEREAS, unauthorized passenger vehicles seem to make their way to the boardwalk on a daily basis, and

WHEREAS, the bollards were installed after the tragic deaths of two tourists in August of 2013, and the additional injury of 17 others, and

WHEREAS, these bollards should be operational and that the appropriate government agencies and parties have immediate access to their controls, and

WHEREAS, a policy exist that the bollards do what they were intended to do, and that is prevent unauthorized vehicles from gaining access to the Venice Boardwalk,

THEREFORE BE IT RESOLVED, that the Oceanfront Walk Committee recommend to the Venice Neighborhood Council to compose a letter verifying that the current bollards are operational, and that they be used as a deterrent to stop unauthorized vehicles from gaining access to the boardwalk, especially during peak hours and high volume activity at the beach, and that a copy of this motion be sent to the LAPD, LAFD, and the CD-11 Council Office.

- 2) Mark Ryavec to present for Venice Arbor Committee
  Discussion of landscaping possibilities along the Boardwalk, including introducing native plants to the dirt strip along the Rose Avenue parking lot.
- 3) Additional Discussion Items
- Vendors that are renting bikes and scooters on the boardwalk.
   This is a safety hazard. Look at banning motorized bikes/scooters.
- **OFW Bathrooms** Upgrade facilities to have a single entrance with a full-time attendants. Have them cleaned more than once a day.
- Unclog the sewers on the boardwalk and then put cement around them Currently the drainage system is backed up (and was covered by sand) but as
  the drains are cleared there should be cement powered around them to stop
  the flow of dirt and sand from piling back onto and into them
- The sand needs to be cleaned off the bike bath Everywhere else you ride outside Venice the bike path is 2 feet wider and cleaner, this sand presents a serious public safety hazard. Tt should be fully cleaned every day
- Put up sand blockers I understand the sand blowing onto the bike path, grass areas etc, is an issue - as previously discussed (and done in other parts of the bike path) dune fencing, sea grass, and curbs would prevent the sand blowing
- Increase and upgrade the overflowing trash cans
- Rose Ave Drainage there's obviously other issues with this but for starters the cement pier needs to be reopened and upgraded

- Vendor Permits / Applications Boardwalk Vendors lottery system reinstated Vendors should have to submit legal paperwork and pay a small fee for their spaces (\$1) it allows for accountability and responsibility. When someone has to work a bit for something they're more likely to care more
- Food drop offs in Rose parking lot there's regularly trash and food left behind from the food drop offs in Rose parking lot. Alternative location?
