13. OLD BUSINESS

MOTION: CITIZEN TASK FORCE ON LAX PARCELS - STAKEHOLDER PETITION

(submitted by Clark Brown, info/signatures in supporting documents)

WHEREAS:

- 1. The Los Angeles Housing and Services Authority and Rand Corporation recently reported there is a 45% increase in homelessness in West Los Angeles and there are 523 homeless in Venice.
- 2. RVs, buses and other vehicles containing homeless people have recently appeared throughout Venice, including on Main, Rose, Venice Blvd and around the Lincoln Place Apartments.
- 3. Councilwoman Park has repeatedly admitted in public forums that there are no available beds, rooms or space in CD 11 for homeless persons.
- 4. Due to *Martin v.Boise* 444 F.3d. 1118 (9th Cir.) and other federal court decisions the City cannot enforce its anti camping ordinances unless it has places for the homeless in the City
- 5. Los Angeles World Airports (LAWA) recently reported to the City Administrative Officer that there are many City owned vacant parcels within LAX, including ones at the corners

of La Cienega and Century and 111TH and Aviation which could be used for homeless shelter and vehicle parking.

- 6. The City has ample resources to make use of these parcels. There is \$1 billion in the current City Budget for homeless services. The Governor has offered 500 tiny homes to Los Angeles for its homeless. The Federal Government recently selected Los Angeles to participate in a 2 year federal program targeting homelessness.
- 7. Despite the above, Councilwoman Park's response to a recent document request served upon her under the California Public Records Act (Gov't C. sec. 6250) establishes she is taking no steps to cause LAWA and the City to establish safe camping and parking facilities on the LAX Parcels.
- 8. Councilwoman Park has established a Citizen Task Force to facilitate the development of recreation facilities in the LAX Northside Project but has failed to establish a similar task force to facilitate the development of facilities for the homeless on the vacant LAX Parcels

THEREFORE: The Venice Neighborhood Council requests Councilwoman Park to forthwith establish a Citizen Task Force with representatives from the Venice, Del Rey and Westchester Neighborhood Councils and the City to:

- 1. Study establishing interim shelter, safe camping and safe parking facilities upon the vacant parcels of land the City owns at LAX
- 2. Evaluate all factors regarding the establishment and operation of such facilities, including but not limited to: the impact of airplane noise upon the residents of the facilities, the impact the facilities will have upon Westchester's residents and businesses, any FAA requirements applicable to the facilities; the availability of shopping and social services to the residents of the facilities, the expense and time involved to establish and operate the facilities.
- 3. Make recommendations to the City based upon the study and evaluation of the Citizen Task Force.

Whereas over the past several years the Venice Neighborhood Council has approved multiple motions recommending denial of the Venice Dell Median Project;

Whereas since that time, due to substantial and still unresolved environmental issues, the Coastal Commission has not accepted the developers' application for a state Coastal

Development Permit and has now issued four Notifications of Incomplete Application;

Therefore, the Venice Neighborhood Council continues to recommend the denial of the Venice Dell Median project and asks that Mayor Bass, City Attorney Feldstein-Soto, and Councilmember Park thoroughly examine the multiple well-documented issues related to this project.

17. PARKING AND TRANSPORTATION

Description: Refers to City Council file 23-0360 The Venice Neighborhood Council, a member of the Westside Regional Alliance of Councils, is concerned about the passage of CF 23-0360, which nullifies Sections 22.482(a) and 22.602 of the Administrative Code and changes the parking space replacement policy when LADOT parking facilities with spaces greater than 25 are transferred to the Housing Department for redevelopment as affordable or supportive housing. The Venice Neighborhood Council is sensitive to how difficult it can be to develop affordable and supportive housing in Los Angeles. We recognize there is a shortage of affordable and supportive housing and believe that Los Angeles would benefit from making it easier to build such housing. Until now, when LADOT-managed parking facilities have been redeveloped, all the parking spaces had to be replaced, increasing the cost of the development. With the passage of CF 23-0360, the spaces will

no longer be required to be replaced. However, we believe that the needs of small businesses, including the need for parking for their customers, have not been adequately considered with the nullification of Administrative Code Sections 22.482(a) and 22.602 and establishment of the new parking space replacement policy. In particular, The Venice Neighborhood Council is concerned about the promised replacement parking at the Venice Dell Project site, formally known as the Reese Davidson project, located at 2102-2120 S Pacific Avenue, 116-302 E North Venice Boulevard, 2016-2116 S Canal Street and 319 E South Venice Boulevard.

MOTION: We respectfully request that Councilmembers representing WRAC member councils who are also members of the City Council Transportation Committee – Councilmembers Park, Yaroslavsky, Raman and/or Hutt – bring a motion in Los Angeles City Council forthwith to further amend the Administrative Code to include concessions for small businesses by replacing the new parking space development footprint. The City should determine how much parking to replace by using a sliding scale for parking replacement based on prior utilization, as well as the availability of nearby public parking, rather than never requiring any replacement.
