- 4. Increasing the Stakeholder Franchise from One (1) to Thirteen (13) or Less for the Position of Community Officer
 - a. Submitted by stakeholder Nick Antonicello
 - b. WHEREAS, the current stakeholder franchise is limited to just one (1) ballot selection in the biannual Venice Neighborhood Council elections, yet thirteen (13) are elected, and WHEREAS, stakeholders are only participating in electing less than half the entire board, and WHEREAS, nearly every elected board member supported revising the community officer selection/election process,
 - c. MOTION: THEREFORE, BE IT RESOLVED, that the Rules & Selections Committee amend the current election procedures for Community Officer beginning with the 2025 elections and that all stakeholders can now select up to thirteen (13) community officers or less, thus maximizing the stakeholder franchise and ensuring a one-man, one-vote compliance.

5. VNC Committee Meeting Spaces Standing Rule

a. Keeping in mind encouragement of stakeholder participation and due to lack of/cost of public parking; ambient noise; business distraction/alcohol consumption; potential attendee expense; unfair bias supporting specific businesses; need for ADA accessibility, and inability to handle oversize participation if necessary, local restaurants and residential homes/businesses are not acceptable locations to hold public VNC committee meetings. To support this, a list of possible locations that meet the criteria for public committee meetings and do not have a charge for use will be compiled by the Vice President within 30 days.





- b. MOTION: The Board of Officers hereby adds to its Standing Rules: VNC Committee Meetings shall not be held in restaurants or private residential homes/businesses, and only held in no cost public meeting spaces, unless there is a board-voted exception, that meet requirements of ADA access and have plentiful and accessible free public parking. Businesses with a free private meeting room and free public parking may be deemed acceptable.

- 6. Request LA City Attorney to Render an Opinion on the Current VNC Board Voting Procedures in the Election of Our 13 Community Officers
 - a. Submitted by stakeholder Nick Antonicello
 - b. WHEREAS, the Venice Neighborhood Council elects thirteen (13) at-large, Community Officers on a biannual basis, and
 - c. WHEREAS, despite having thirteen officers elected at-large, a Venice stakeholder is restricted to a single selection of just one (1), and
 - d. WHEREAS, such an election process restricts and minimizes all stakeholders in participating in such a process that allows a full and complete voter franchise, and
 - e. WHEREAS, Venice stakeholders are only duly participating in 38% of the board's full elected membership, and
 - f. WHEREAS, these same Venice stakeholders are being denied full ballot access, which may be in conflict with the rules and procedures of DONE (Department of Neighborhood Empowerment of LA), the Los Angeles City Charter, and the Constitution of the State of California, and
 - g. WHEREAS, a full review of these flawed and constitutionally questionable election practices should be reviewed by a legal and qualified authority,
 - h. MOTION: THEREFORE BE IT RESOLVED, that the Venice Neighborhood Council ask in writing that the Office of the LA City Attorney review the current selection and voting process of the position of Community Officer(s) for the Venice Neighborhood Council and further offer guidance and judgement if the current procedures in place violate the spirit of the "one man, one vote" principle, and that the LA City Attorney render an opinion if such voting practices are in conflict with the rules and regulations of DONE and the Los Angeles City Charter and that the BY LAWS and Standing Rules of the VNC be in accordance with the proper and legal procedures in selecting and electing the thirteen Community Officers of the Venice Neighborhood Council before the scheduled biannual elections in 2025.
