NEW BUSINESS:

1. Stakeholder Motion from Mark Ryavec – **Resolution to Follow Recent Ninth Circuit Court of Appeals Decision Allowing Citations and Clearing of Encampments in Instances When Homeless Individuals Living in Venice Have Refused Available Shelter**

a. Item Description:

Whereas, there are homeless individuals living in encampments, tents, canopies, shanties or without cover on public property throughout Venice, including but not limited to: Flower and Lincoln, Rose Avenue at Whole Foods, Washington Boulevard near or at Ocean Front Walk, Main Street, Venice Post Office, Speedway, Penmar Park and in the Venice Beach Recreation Area (i.e., Venice Beach); and,

Whereas, the Los Angeles Housing Services Authority and Rand Corporation recently reported there was a 45% increase in homelessness in West Los Angeles and there are 523 homeless in Venice, and this represents the third largest homeless population after Skid Row and Hollywood; and,

Whereas, under the city's current version of LAMC Sec. 41.18, street/sidewalk camping is only prohibited in small areas around schools, childcare centers, parks, under tunnels and freeways, and a few designated high-crime spots, allowing encampments in most of the city's residential and commercial areas, frequently near residents and shops; and,

Whereas, service providers report that a significant percentage of the homeless population refuses to accept shelter or accepts shelter and for various reasons later leaves shelter and returns to the street; and,

Whereas, in 2010, to address the presence of over 250 recreational vehicles and campers on Venice's streets, the city adopted a Venice-specific ordinance banning vehicles over 7 feet tall or 22 feet long from city streets from the hours of 2 to 6 AM; and,

Whereas, the Ninth Circuit Court of Appeals recently acknowledged in a case brought by the City and County of San Francisco that those who refuse specific offers of shelter are considered voluntarily homeless and as such a 2022 injunction, which restricted city workers from moving or clearing homeless encampments, does not apply, and San Francisco has thus returned to clearing encampments after offers of shelter have been made (<https://sfstandard.com/2023/09/25/san-francisco-to-resume-enforcing-laws-against-homeless-people-who-refuse-shelter-mayor/>)

2. **Board Member Motion from Clark Brown – Resolution for Ordinance to Provide Better Enforcement Against Homelessness Uses in Venice**

a. **Item Description:**

WHEREAS:

1. There are homeless encampments, tents and oversized vehicles used by homeless persons throughout Venice, including but not limited to: the Flower-Lincoln corner, Rose Avenue at Whole Foods, Frederick and Lake, Main Street, Washington and Venice Blvds and Penmar Park.
2. Los Angeles Housing and Services Authority and Rand Corporation recently reported there is a 45% increase in homelessness in West Los Angeles and there are 523 homeless in Venice.
3. This exists even though for several years the City has had an anti camping ordinance, LAMC sec. 41.18. It has not been effective because it sets so many conditions for its enforcement that it can only be enforced in narrow circumstances which prevent its effective enforcement.
4. Homelessness is more widespread in Venice than any other part of the City except Skid Row and Hollywood. Therefor it is appropriate for the City to adopt a homelessness

ordinance for Venice only as it did in 2010 with Ordinance 181413, which provides special procedures applicable to Venice only for Oversized Vehicle signs.

5. The Ninth Circuit Court of Appeals recently acknowledged in a case brought by the City and County of San Francisco that those who refuse specific offers of shelter are considered voluntarily homeless and as such a 2022 injunction, which restricted city workers from moving or clearing homeless encampments, does not apply, and San Francisco has thus returned to clearing encampments after offers of shelter have been made (<https://sfstandard.com/2023/09/25/san-francisco-to-resume-enforcing-laws-against-homeless-people-who-refuse-shelter-mayor/>)

The Venice Neighborhood Council supports CF 23-0730 to create a RV Rehousing Pilot in the 11th Council District. The most recent Los Angeles Homeless Services Authority (LAHSA) Point-in-Time Count shows a 40% increase since 2018 in the numbers of people experiencing homelessness in RVs. Due to the environmental, health, and safety risks to both those living in RVs and to nearby residents, the VNC supports this motion in order to provide solutions such as RV safe parking, RV storage, and both interim and permanent supportive housing for those living in RVs. The VNC also specifically requests that the RV Rehousing Pilot be implemented in areas in Venice, if possible, where people are experiencing RV homelessness.

The Venice Neighborhood Council supports CF 23-0914 which calls for recommendations for a citywide program to designate streets where RVs/oversize vehicles can safely park with access to services, including housing navigation, portable restrooms, automotive repair and septic tank disposal. The program would also restrict RV parking in residential and other sensitive areas. Venice and other neighborhoods throughout the City have been impacted by increased RV parking with lack of support services, which can in some cases result in illegal discharge of hazardous substances into storm drains and public rights-of-way, loss of parking for non-vehicle dwellers, reduced line-of-sight at intersections and driveways and other impacts. Therefore, the VNC supports CF 23-0914.
