Helen Fallon presented a proposal for a Board make-up with neighborhood representation comprised of 10 unique area neighborhoods; 3 at-large community officers and 1 community interest officer:

The total Board would remain at 21 members. The need for 10 area neighborhoods came from the attempt to make the areas comparable in population while recognizing boundaries for neighborhoods.

Discussion with stakeholders and committee members let to an agreement to move the proposed boundary between Areas 4 and 5 from Pacific Ave to Main Street which would place the walk-street properties in the same area.

The committee will draw a simplified boundary map for presentation at their next meeting.

No action or vote was taken on the proposal.
