VNC Motion passed October 17, 2023 asks Rec & Parks Commissioners and Executive Staff to meet with VNC regarding plans for Venice parks, now and ongoing. No response yet. Immediate concerns re:

Centennial Park - central green space removed; disregard for historic elements; disregard for Carousel proposed by this committee & supported by VNC; enclosing with fence and not creating access to AK

Blvd as this committee has proposed. RAP did not consult with VNC nor community. RAP plan violates CA Coastal Permits. Exorbitant cost \$200,000 while repair might have cost \$10,000. And while other Venice parks in dire need of maintenance, repairs and improvements.

Westminster Ocean Front Walk Playground demolished without notice. No evidence of dangerous conditions necessitating demolition. No plans for replacement. Numerous families are upset and want input.
