- Call to Order Approved August and September meeting minutes, Andreas moved, Isabelle 2nd, 4-0-0.
- Public Comments on non-agenda items. Steve Bradbury comments on trees that were cut down on Hurricane. SRW emailed the city twice and received emails in return.
- Reports
  - a. Chair Report Andreas Kemkes Congress of Neighborhood: CEMO (Climate Emergency Mobilization Office) under Board of Public Works work on mitigation of heat in LA and increased tree canopy is part of heating mitigation.
  - b. CFAC Isabelle Duvivier Marianne King gave a good albeit depressing report on new housing plans from the state, Citywide Housing Incentive Plan Ordinance and other ordinance HESMD etc. None say anything about trees. All give big density bonuses. c. VVG Report – Lots of good work on Sunset with a robust volunteer group, beach dune project was surveyed by Isabelle and Noel. 8 trees planted at Oakwood Park. Tomorrow VVG will be planting on Rose.

### 4. NEW BUSINESS

- a. Protection of Trees Andreas mentioned that he would monitor Tree Removal List for Venice and Mar Vista, collaborate with Mar Vista Arbor Group.
- b. Water Foundation Measure W Grant Janin Paine spoke about and it's early days.
- c. LUPC Mark Mack urban forestry motion Green Spaces Ideas identify city land, which of the median Islands belong to the city, which to Caltrans or DOT. Identify streets and alleys that could use more trees. We could start developing our own priority list of streets in need of canopy. City can't be relied upon at this point, they're most focused on disadvantaged communities. In CD11, it goes to low income high pollutant neighborhoods. Create an Urban Forestry Management Plan for Venice, we would like to have input on this.
- d. Urban Forestry Management Plan update Isabelle spoke How can we combine ideas and feed them to Rachel, who will be doing a neighborhood-wide urban canopy plan. The city's goal is only a small jump to 15% in like 10 years. Rachel is holding a series of chapter reviews to get priority feedback and refine goals, structure action plan and plan for outcomes. Been discussing funding and overall goals. 3 more meetings are coming up. Implementation plan ahead. We need to feed information specific to the Venice climate zone. Clay soil, salty air, cooler temps.

- a. Letter to Landscape Architect for Rose to specify Species Waiting for Charles Miller to send a tree list for 4 foot parkways for Penmar Revitalization Project on Rose.
- b. Artificial Turf Restrictions Andreas Kemkes CIS made. Andreas to report on progress and next steps. (In. 8/16/24) The City Council substituted a more watered down version which was passed. Neighborhood Council Sustainability Alliance has drafted a letter to further the mission of banning artificial turf.. We need a motion to sign that letter from VNC Board. Isabelle suggests it should be put on next agenda. Andreas will send more information to Brian Averil.
