
5) How will this grant be used to primarily support or serve a public purpose and benefit the public at-large. (Grants cannot be used as rewards or prizes for individuals)

BEAUTIFY LA is a public charity whose mission is to Beautify L.A. through homeless support, trash and graffiti cleanups, gardening, and hosting events to support community engagement through an educational and family friendly environment.

Community Enhancement: The intent of the grant is to create visually appealing public spaces that reflect the culture and diversity of the community. This includes activities such as landscaping, planting native trees and flowers, and creating community gardens that not only beautify the area but also encourage local biodiversity.

Community Engagement and Empowerment: We aim to actively involve residents in the beautification process, empowering them to take ownership of their environment. Through volunteer programs, workshops, and collaborative art projects, community members will have opportunities to learn skills, share ideas, and work together towards a common goal.

Total Budget: \$4,750

Program Materials and Supplies - \$1,750

- Gardening Supplies & Personnel: (e.g., seeds, soil, plants for community garden, personnel, and community event) \$1,090
- Cleaning Supplies: (e.g., trash bags, gloves, safety equipment) \$380
- Art Supplies: (e.g., paint, brushes, canvases for community events) \$280

Community Engagement Events - \$1,430


- Workshops and Training Sessions led by an educator: (e.g., gardening workshops, art workshops; The cost for an educator is \$200 per day for two events) \$400
- Community Clean-Up Days: (e.g., gloves, bags, t-shirts, food, and refreshments for volunteers/personnel) \$850
- Promotional Materials: (e.g., flyers, posters, and social media ads) \$180

Support Services for the Homeless - \$1,180

- Outreach Services: (e.g. outreach personnel workers to service homeless) -\$800
- Outreach Supplies: (e.g., hygiene kits, food) \$250
- Collaboration with Local Service Providers: (e.g., team members using 311, LA-HOP, Circle, food banks, and shelters to further our mission) \$130

Administrative Costs - \$490

- Insurance: (e.g., liability insurance for events) \$240
- Miscellaneous Supplies: (e.g., office supplies, printing paper, printer, and transportation costs)
- \$150
- Accounting/Grant Reporting Services: \$100



Through this grant proposal, Beautify LA seeks to collaborate with the Neighborhood Council to create a shared vision for a more beautiful, green, and vibrant community, enhancing the quality of life for all residents.
