SECTION II - PROJECT DESCRIPTION

4) Please describe the purpose and intent of the grant.

Friends of Westminster is applying on behalf of the ADA-accessible community garden at Westminster Elementary on Abbot Kinney.

- * COMMUNITY SERVICE: The garden is open to the public one day a month (for our community garden days, which are frequently attended by locals as well as clubs like Verdant Venice and LA Works); to select members of the public on a regular basis (to harvest food from the garden, like our recent bumper crop of fava beans); and to local school children and their families on a regular basis (where it serves as a garden, a science lab, and a kitchen).
- * ENVIRONMENTAL CONTRIBUTIONS: The Westminster Garden is a verdant green space in a big sector of asphalt (and indeed used to be covered in asphalt itself), improving air quality for locals; a source of fresh produce for locals; and serving as a natural habitat for native plants and animals (like owls, ducks, and rabbits).
- * CULTURAL CONTRIBUTIONS: Our plan in the next year is to establish a small "Grandma & Grandpa Garden" of about 60x80ft within the Westminster Garden. We hope to invite community members and affiliates of the school to plant fruits and vegetables from their native countries, so students can learn about other cultures through food and plant biology.
- 5) How will this grant be used to primarily support or serve a public purpose and benefit the public at-large. (Grants cannot be used as rewards or prizes for individuals)

We will use the funds to accomplish three goals directly related to the Venice Community at large, corresponding to the goals listed above:

- 1. COMMUNITY SERVICE: We are asking for \$1,000 to supply refreshments (drinks and snacks) to four of our monthly Community Garden Workdays, where members of the community are invited to join us in rolling up our sleeves and getting dirty beautifying the garden.
- 2. ENVIRONMENTAL CONTRIBUTIONS: We are hoping to plant 8 medium-sized trees (10 gallons or larger) by the school cafeteria, along Westminster Ave. just in from where it hits Abbot Kinney. This will increase the neighborhood verdancy and improve air quality along Abbot Kinney Blvd. To do this, we are asking VNC to sponsor the trees and the soil needed to plant the trees and replenish the garden proper.
- 3. CULTURAL CONTRIBUTIONS: A critical part of our cultural pedagogy is our outdoor garden kitchen, which includes several portable induction cooktops, which are powered by our garden solar panels. Unfortunately, the solar panels' battery just died, and we need to replace it. We have been able to source the labor for this repair for free from a community member, but need to cover the cost of a new battery.
