General Public Comment period; however, the issue raised by a member of the public may become the subject of a future Board meeting. Public comment is limited to 30 seconds per speaker, unless adjusted by the presiding officer of the Board. In the event of a disruption that prevents the eligible legislative body from broadcasting the meeting to members of the public using the call in option or internet-based service option, or in the event of a disruption within the eligible legislative body's control that prevents members of the public from offering public comments using the call-in option or internet-based service option, the eligible legislative body shall take no further action on items appearing on the meeting agenda until public access to the meeting via the call-in option or internet-based service option is restored. Actions taken on agenda items during a disruption that prevents the eligible legislative body from broadcasting the meeting may be challenged pursuant to Section 54960.1.(C) The eligible legislative body shall not require public comments to be submitted in advance of the meeting and shall provide an opportunity for the public to address the legislative body and offer comments in real time. Notwithstanding Section 54953.3, an individual desiring to provide public comment through the use of an internet website, or other online platform, not under the control of the eligible legislative body, that requires registration to log in to a teleconference may be required to register as required by the third party internet website or online platform to participate. (E) (i) An eligible legislative body that provides a timed public comment period for each agenda item shall not close the public comment period for the agenda item, or the opportunity to register, pursuant to subparagraph (D), to provide public comment until that timed public comment period has elapsed. (ii) An eligible legislative body that does not provide a timed public comment period, but takes public comment separately on each agenda item, shall allow a reasonable amount of time per agenda item to allow public members the opportunity to provide public comment, including time for members of the public to register pursuant to subparagraph (D), or otherwise be recognized for the purpose of providing public comment. (iii) An eligible legislative body that provides a timed general public comment period that does not correspond to a specific agenda item shall not close the public comment period or the opportunity to register, pursuant to subparagraph (D), until the timed general public comment period has elapsed. 12. OLD BUSINESS

OFW/BIKE PATH MOTORIZED VEHICLE ORDINANCE ENFORCEMENT

DESCRIPTION: In 2022, in recognition of the significant dangers created by operating and renting motorized vehicles to be operated on Ocean Front Walk, the Boardwalk and the Bike Path, the City of Los Angeles enacted ordinances with penalties for businesses or individuals violating these laws. The fine for the first infraction is \$100. Subsequent infractions are \$250 or prosecution as a

misdemeanor or more. LAPD has not been enforcing these ordinances and the number of motorized vehicles operating and being rented to operate on the Boardwalk and Bike Path has increase exponentially. Enforcement of these laws with notice to the public and to businesses is essential to the safety of all visitors to Venice Beach. With even sporadic weekly enforcement, the problem can be eliminated. The cost of LAPD attention to this will be offset by the fines collected from violators. Due to the serious danger that violations present, we recommend that the first infraction fine for violating the motorized vehicle ordinances be raised to \$250. (Note that this is the fine for the less dangerous activity of walking a dog on leach on the beach.) In lieu of fining non-resident rental customers, the fine could be levied against the rental company. As the law describes, it is the duty of the rental company to warn its customers that motorized vehicles may not be operated at Ocean Front Walk, the Boardwalk or Bike Path. The solution to this problem is NOT to add barriers, fencing or obstacles to our crowed Boardwalk. That would create new dangers for all pedestrians, including ADA accessibility, on the Boardwalk and it would do nothing, or would likely increase the problem on the Bike Path.

MOTION: The Board of the Venice Neighborhood Council requests that the Los Angeles Police Department give notice and enforce all laws and ordinances which preclude the use and rental of all motorized vehicles on Ocean Front Walk, the Boardwalk and the Bike Path per Los Angeles Municipal Code Section 63.44, Ordinance No.187667, an ordinance adding Section 71.31 to Article 1, Chapter VII of the Los Angeles Municipal Code and any and all other controlling ordinances. We recommend that the first infraction be increased to \$250.00 We request that that the Department of Recreation and Parks, the Business Improvement District, Council District 11 and the Venice Neighborhood Council each assist in amplifying notice to the Venice community, to visitors on Ocean Front Walk, and to all rental businesses of this law and its enforcement. 14. PARKING AND TRANSPORTATION

A. BUS LANE VIOLATION ENFORCEMENT PILOT PROGRAM: CIS TO COUNCIL FILES: 24-1151 AND 21-122 (3-0-1) Item 14A – Alley Bean, Steve Bradbury – Motion Carries

MOTION: The Venice Neighborhood Council, a member of the Westside Regional Alliance of Councils (WRAC), opposes the allocation of revenues from the Bus Lane Violation Enforcement Pilot Program to items that are not specifically related topublic transit. We therefore oppose using these funds for "Transportation improvements and temporary staffing related to the 2028 Olympic and Paralympic games." A \$200 million federal grant is already in the works to help with the proposed use of public buses at the 2028 Games.

DESCRIPTION: This motion is to support a WRAC motion, listed above, that objects to certain specific language regarding spending of monies gathered via the Bus Lane Enforcement Program

B. PROTECTED BIKE LANES ON WASHINGTON BLVD WEST OF OXFORD (3-1-0)

The VNC supports the creation of protected bike lanes along Washington Blvd, west of Oxford to Dell Ave as proposed by the surrounding neighbors to increase bicycle safety, reducing illegal RV parking and vehicular speeding. This proposal would include no tradeoffs in parking and travel lanes by swapping the existing bike lanes with parking.
