When prompted by the presiding officer, to provide public input at the Neighborhood Council meeting the public will be requested to dial *9 or use the Raise Hand option, to address the Board on any agenda item before the Board takes an action on an item. Comments from the public on other matters not appearing on the agenda that are within the Board's jurisdiction will be heard during the General Public Comment period. In the event of a disruption that prevents the eligible legislative body from broadcasting the meeting to members of the public using the call in option or internet-based service option, or in the event of a disruption within the eligible legislative body's control that prevents members of the public from offering public comments using the call-in option or internet-based service option, the eligible legislative body shall take no further action on items appearing on the meeting agenda until public access to the meeting via the call-in option or internet-based service option is restored. Actions taken on agenda items during a disruption that prevents the eligible legislative body from broadcasting the meeting may be challenged pursuant to Section 54960.1.(C) The eligible legislative body shall not require public comments to be submitted in advance of the meeting and shall provide an opportunity for the public to address the legislative body and offer comments in real time. Notwithstanding Section 54953.3, an individual desiring to provide public comment through the use of an internet website, or other online platform, not under the control of the eligible legislative body, that requires registration to log in to a teleconference may be required to register as required by the third party internet website or online platform to participate. (E) (i) An eligible legislative body that provides a timed public comment period for each agenda item shall not close the public comment period for the agenda item, or the opportunity to register, pursuant to subparagraph (D), to provide public comment until that timed public comment period has elapsed. (ii) An eligible legislative body that does not provide a timed public comment period, but takes public comment separately on each agenda item, shall allow a reasonable amount of time per agenda item to allow public members the opportunity to provide public comment, including time for members of the public to register pursuant to subparagraph (D), or otherwise be recognized for the purpose of providing public comment. (iii) An eligible legislative body that provides a timed general public comment period that does not correspond to a specific agenda item shall not close the public comment period or the opportunity to register, pursuant to subparagraph (D), until the timed general public comment period has elapsed. Comments from the public on other matters not appearing on the agenda that are within the Board's jurisdiction will be heard during the General Public Comment period. Please note that under the Brown Act, the Board is prevented from acting on a matter that you bring to its attention during the General Public Comment period; however, the issue raised by a member of the public may become the subject of a future Board meeting. A. GEO-FENCING E-VEHICLES (NOEL JOHNSTON)

Whereas the north end of the Venice Boardwalk and the private property and right-of-way adjacent has been inundated with e-scooters and e-bikes, primarily Veo, Spin and Gcoo, the VNC Board of officers asks that CD11 and LA Rec & Parks request of these companies that all such vehicles be geofenced immediately on all of Ocean Front Walk starting at the Marine Apron (located to the immediate north of 101-103 Ocean Front Walk) and extending south to the Washington Blvd border and that e-bikes and e-scooters are not left on the Bike Path, Ocean Front Walk, or the Marine Apron, with letters sent to:

B. OPPOSITION TO COMMERCIAL ADVERTISING ON BILLBOARDS ON COUNTY LIFEGUARD STATIONS (ROBIN RUDISILL)

MOTION: the Venice Neighborhood Council strongly opposes any commercial advertising and signs/billboards in the beach areas and therefore requests that the City Councilmembers for the beach areas, Councilmember McOsker and Councilmember Park, strongly oppose the proposed Coastal permit amendment to expand the number, size and locations of this commercial advertising sign/billboard program.

DESCRIPTION: Whereas, L.A. County is requesting "after-the-fact" approval of an amendment to a Coastal Development Permit (CDP), permit no. 5-02-009-A1, to modify certain aspects of an existing permit related to advertising signage on 111 lifeguard stations, from Will Rogers State Beach to Cabrillo Beach, spanning multiple cities and planning jurisdictions; Whereas, such amendment includes a doubling of the number of signs on each lifeguard station from one to two, a doubling of the size of the signs to a width of 5 feet and a height of 4 feet, as well as an increase in the number of permitted locations to now include Cabrillo Beach and other areas that were not included in the 2002 CDP; Whereas, the California Coastal Act affirms the right of the public to enjoy access to the coast and to experience it in its natural state but commercial signage, by its very nature, runs counter to that mission; the beach is not a

marketplace, it is not a billboard, but rather it is a public sanctuary that belongs to everyone, not to advertisers; allowing this kind of visual commercial intrusion undermines public trust and sets a dangerous precedent for further commercialization of our shared coastal spaces; Whereas, the County General Plan explicitly says “Prohibit outdoor advertising and billboards along scenic routes, corridors, waterways, and other scenic areas,” and the City’s General & Specific Plans protect the scenic and open space areas, including beaches, from billboards; Whereas, even though the County has represented that 100% of the advertising revenue will be used for funding existing, expanded, or new recreational and educational beach and ocean youth programs, that isn’t an excuse to violate the Coastal Act by degrading our precious open space/ beaches as there are any number of worthy programs; and Whereas, the local jurisdictions where these billboards will be located were not notified of this program and the CDP amendment.

C. OPPOSE RFP FOR INTERACTIVE KIOSK EXPERIENCE SIDEWALK KIOSK PROGRAM (3-0-0)

MOTION: The VNC file a CIS in opposition to the IKE Sidewalk Kiosk Program, City Council file 22-1154-S1

DESCRIPTION: Refers to City Council file 22-1154-S1 The Venice Neighborhood Council, a member of the Westside Regional Alliance of Councils (WRAC), opposes Council File 22-1154-S1 and the issuance of a Request for Proposals (RFP) for the interactive digital kiosk program, because it would: allow installation of hundreds of 8 to 9 foot tall two-sided digital advertising kiosks on sidewalks through the City, which WRAC previously opposed in January 2023 (<https://westsidecouncils.com/motion/postpone-caltrans-repaving-project-on-the-405/>), and 2) directly compete with, and undermine, the success of the City’s Sidewalk and Transit Amenities Program (STAP) and other community benefit programs that the City and its transit riders rely upon to provide much-needed shade, shelter, transit information and public service announcements. <http://cityclerk.lacity.org/lacityclerkconnect/index.cfm?fa=ccfi.viewrecord&cfnumber=22-1154-S1>

D. AMEND LAMC 56.15-NO RIDING E-BICYCLES ON SIDEWALKS

MOTION: The VNC shall send the following letter, requesting that LAMC 56.15 be amended as follows: The Venice Neighborhood Council, a member of the Westside Regional Alliance of Councils (WRAC), supports banning all classes of e-bicycles (e-bikes) from riding on a sidewalk or a boardwalk in the City of Los Angeles, to address serious public safety concerns and reports of rising accidents, injuries and deaths from collisions between e-bikes and pedestrians. To accomplish this

objective, the VNC supports the Los Angeles City Council passing, and the Mayor approving, an ordinance updating Los Angeles Municipal Code Section 56.15. BICYCLE RIDING – SIDEWALKS to read (additions in italics/underlined): 1. No person shall ride, operate or use a bicycle, unicycle, skateboard, cart, wagon, wheelchair, roller skates, or any other device moved exclusively by human power, on a sidewalk, bikeway or boardwalk in a willful or wanton disregard for the safety of persons or property. (Amended by Ord. No. 166,189, Eff. 10/7/90.) No person shall ride, operate or use any class of electric bicycle (e-bike) on a sidewalk or boardwalk in the City of Los Angeles. (Amended by a new Ordinance passed by the LA City Council.) 2. No person shall ride, operate or use a bicycle, electric bicycle (e-bike) or unicycle on Ocean Front Walk between Marine Street and Via Marina within the City of Los Angeles, except that bicycle, electric bicycle (e-bike) or unicycle riding shall be permitted along the bicycle path adjacent to Ocean Front Walk between Marine Street and Washington Boulevard.(Amended by Ord. No. 153,474, Eff. 4/12/80.) (Amended by a new Ordinance passed by the LA City Council.) 3. No person shall operate on a beach bicycle path, or on an area of a beach which is set aside for bicycle, electric bicycle (e-bike) or unicycle use, any bicycle, electric bicycle (e-bike) or tricycle which provides for side-by-side seating thereon or which has affixed thereto any attachment or appendage which protrudes from the side of the bicycle, electric bicycle (e-bike) or tricycle and is used or designed to carry another person or persons thereon. (Amended by a new Ordinance passed by the LA City Council.) VNC further requests that Councilmembers representing WRAC member councils (Park, Yaroslavsky, Hutt and/or Raman) bring a motion in Council requesting amendment of Municipal Code Sec. 56.15 as set forth above.

OLD BUSINESS

13. MOTION FOR PROMPT AND EFFECTIVE CITY ACTION ON UNHOUSED PERSONS.RVS AND OVS ON WASHINGTON BETWEEN ABBOT KINNEY AND BEACH (CLARK BROWN) Moved Clark, Second Jason – Motion Carries 6-5-7-1

MOTION: The City should forthwith aggressively ticket and tow all vehicles parked on both sides of Washington Blvd. between Abbot Kinney and Beach which are continuously parked over 72 hours in violation of posted signs or do not bear current license tags or which are unsafe. Upon passage and finalization of this Motion, the Secretary of the Venice Neighborhood Council shall forthwith forward it to Councilperson **Substitute wording?**

DESCRIPTION:

WHEREAS

(1) For many months unhoused persons have illegally parked their RVs and OV's on both sides of Washington Blvd between Abbot Kinney and Beach.

(2) Residents and businesses, including The Kinney, Hangers, Marina del Rey Cleaners, the Marina del Rey Liquor Mart, the owners of apartments on the north side of Washington and residents of those apartments state RVs and OV's are parked continuously on both sides of Washington Blvd and are moved only for street sweeping. 2 huge OV's parked in front of the Kinney have been there for 3-4 years. The residents complain the vehicles deprive the residents of parking for themselves and their guests. They complain the vehicles' generators create noise, their occupants dump trash and human waste in the gutters, enter private property for water, paint graffiti on utility poles, have short term visitors who apparently are dealing drugs, are an eyesore and impinge on the residents' sense of privacy.

(3) The occupants of these vehicles live for free on Washington Blvd without paying taxes for the City services the City provides to the Blvd. By contrast the residents and owners of property on Washington Blvd. do pay taxes for those services either directly or indirectly.

(4) On 4/30/24 on the North side of Washington Blvd between Abbot Kinney and Beach there were 15 oversized vehicles, 7 were dilapidated and 4 had expired tags. On the South side of Washington Blvd there were 7 oversized vehicles, 5 were dilapidated, and 3 had expired tags.

(5) Vehicle Code sec. 22651 G)(k) and 22669(d) authorize the City to remove vehicles parked over 72 hours on in violation parking restriction signs or which don't bear current license tags or are unsafe.

(6) LAMC secs. 11.00(1) and 91.9002 authorize the City to abate and arrest persons committing any nuisance which includes any violation of law and "loitering, excessive littering, illegal parking, excessive loud noises (especially in the late night or early morning hours) "

14. MOTION TO RAISE AWARENESS OF CITY ASSETS AT FARMER'S MARKET PARKING LOT 701 (5-0-0)

MOTION: Venice Arbor Committee - Motion to Raise Awareness of City Assets at Farmer's Market Parking Lot 701 Whereas City Council has passed a motion (Case File 15-1138-S42) to study the alternative use of Parking Lot 701 (Farmer's Market Lot) instead of Parking Lot 731 for housing along Venice Boulevard (known as the Venice Dell Community Housing Project); Whereas Parking Lot 701 possesses a large number of city assets, including a large number of Native Trees – 55 x 30 year-old Sycamores, 29 Coast Live Oaks - and forward-thinking Low Impact Development swales that carved out concrete from the greater parking lot - comprising 2240 cumulative years of tree growth; Whereas Venice community members worked together with CALTrans and received considerable grant monies to plant the tree assets now growing in Parking Lot 701, approximately 30 years ago, and are part of what comprises what is likely the largest concentration of Native Trees within Venice (the trees along Venice from Lincoln to Pacific); Whereas recent studies from USC show that the trees of Los Angeles are offsetting close to 30% of carbon emissions during the year, 60% during the summer, and any loss of offset poses a loss of important city services; Whereas construction of housing units at Parking Lot 701 would necessarily remove trees growing in the footprint of such designed building and would challenge the health of or kill trees growing in the parkway; Venice Neighborhood Council resolves to urge the city to acknowledge the tree and design assets planted and growing since approximately 30 years ago at Parking Lot 701, the removal of which would represent a massive loss of shade, cooling, carbon offset, property value of neighboring buildings, habitat and beauty. Venice Neighborhood Council resolves to urge that the city institute strict

tree protection measures, as per section 4 of the Recreation and Parks Department tree care guidelines, such that parkway trees near Parking Lot 701 next to the construction will be fenced off and watered during construction. Following passage this Resolution shall be forwarded to Mayor Karen Bass, Councilwoman Traci Park, general managers of the Department of Public Works and the Department of Transportation, the commissioners of the Department of Public Works and the Department of Transportation. Sarah Wauters makes motion, Barry Campion seconds it. 5-0-0.

DESCRIPTION: This is a motion to include the consideration of city urban canopy assets in the parking lot that is being researched for housing. Full verbiage of the motion is attached.

B. INCOMING BOARD FIRST MEETING REQUIREMENTS (5-0-0)

Mover Steve, Second Jim -- Motion Carries 7-6-1-5-0-1

MOTION: As a Standing Rule, the agenda of the first Board meeting of each administration must include the following AFTER the new Board is sworn into office: 1. Information about open Board seats and how to apply for them, included in the President's Report. 2. Appointment of chairs of the Standing Committees whose chairs are not set by the VNC Bylaws. The Bylaws set chairs for Budget and Finance, Communications, Land Use and Planning, and Outreach. 3. Evaluation of requests to extend termination date for ad hoc committees that requested an extension and appoint chair. 4. Adoption of the June Monthly Expenditure Report. 5. Adoption of the Fiscal Year Administrative Packet. 6. Selection the Community Officers who will be on AdCom. 7. If the President has selected a Parliamentarian, that person is officially appointed now. (The Parliamentarian is placed on the Board email list and is given an email address.)

DESCRIPTION: A lot of actions must occur at the first Board meeting of each administration. To ensure a smooth transition between the outbound board and the incoming Board, a set of clear actions for the first meeting

C. COMMITTEE CHAIR SUCCESSION PLANNING (5-0-0) Returned to Com.

MOTION: As a Standing Rule, no VNC committee may have co-chairs. All committees, excluding those whose chairs are elected, may have vice-chairs. Vice chairs shall be awarded that status in the same manner as committee chairs. In event the chair does not continue in that function until the next administration or the termination of the committee, the vice-chair shall become the chair and a new vice-chair will be appointed.

DESCRIPTION: Whereas the VNC bylaws do not mention "co-chair", there is no automatic successor if one of the co-chairs ceases in that function. Robert's Rules recommends permitting vice-chairs.

D. MODIFICATION TO STANDING RULE 31. BUDGET APPROVAL (4-1-0) Returned to Com.

MOTION: The VNC approves the following modification of Standing Rule Section 31: Section 31: Motion Budget Approval: "If a proposed motion requires VNC financial expenditure, prior to being placed on a VNC board agenda by the appropriate committee or community member, it shall be reviewed by the Budget & Finance Committee solely to (1) confirm funds are available within the VNC budget, whether currently allocated or requiring a transfer from another line item, and where appropriate, (2) ensure total compliance with all Department of Neighborhood Empowerment (Department) and Los Angeles City requirements.

DESCRIPTION: Section 31 of the VNC Standing Rules states: “All financial items must be vetted by the Budget & Finance Committee prior to being placed on a VNC Board agenda.” The term “vetted” is defined as making a careful and critical examination, assessing suitability or conducting a structured process of appraisal. According to the VNC Bylaws, the role of the Budget & Finance Committee is “to ensure total compliance with all Department of Neighborhood Empowerment (Department) and Los Angeles City requirements.” The Budget & Finance Committee does not have the authority to consider the merits of any proposed agenda item submitted by any other committee. Further, all motions with a financial component should be submitted to the VNC Board by the committee from which it has been generated.

E. ROBERTS RULES STANDING RULE (5-0-0) Returned to Com.

MOTION: Effective July 1, 2025, all current Venice Neighborhood Council board members and VNC Committee chairs shall be required to become conversant in Roberts Rules. VNC committee members who are not on the VNC board may, optionally, also complete this training. This required training shall be completed within 45 days of (re) joining the VNC Board or being confirmed as Chair of a committee. Failure to do so will result in the loss of your right to submit, propose, second and/or vote on any motion whether in committee or at a board meeting until the training(s) are completed. Participants shall notify the VNC Secretary via email they have completed the training.

DESCRIPTION: The Venice Neighborhood Council Bylaws state in Article XII: “The Board shall use Robert's Rules of Order (current version) as the Governing Parliamentary Authority of the VNC.” However, continuing conflict among Board members during meetings has become problematic and led to unnecessary delays, conflict and disrespectful interactions often in conflict with Article XIV, Section 1, Code of Civility.

16. MOTION TO INSTALL FENCE BARRIERS ON OCEAN FRONT WALK (8-0-0)

Motion pulled by OFW Chair

MOTION:

The Venice Neighborhood Council requests the City to purchase and install sufficient fence barriers on Ocean Front Walk at the locations identified in Para. 2 to block motorized vehicles from entering Ocean Front Walk.

Upon passage of this resolution, the VNC Council will forward it to the offices of Councilwoman Park, the Manager of the Los Angeles Department of Parks and Recreation and the Commanders of the LAPD and LAFD stations for Venice.

1. Motorized vehicles on Ocean Front Walk are dangerous to pedestrians using the walk.

Installing fence barriers, such as the ones shown on the attachment to this Motion, at the north and south ends of Ocean Front Walk and places in between, which afford entrance to Ocean Front Walk such as Windward Avenue, would decrease motorized vehicles on Ocean Front walk and would be inexpensive to purchase and easy to install and to remove in emergencies.

MOTION: The Board of Officers hereby adds the following to its Standing Rules: Code of Conduct: The Rules and Elections Committee will be the centralized tracking and verification to ensure all VNC Stakeholder Committee Members are in compliance of their required training. All Committee Chairs are responsible for ensuring their Committee members' Code of Conduct is current.
