**Overview:** Venice is vulnerable to multiple natural and human caused hazards. The Venice Community Resiliency Committee(VCRC) under the oversight and with the support of the Venice Neighborhood Council provides ongoing training and awareness programs so that Venice may become a disaster resilient community. The VCRC 2025-2026 continues a whole community approach while emphasizing the threat of a damaging Tsunami.

- Two Community Emergency Response Team (CERT) classes in Venice. Date: TBD
- Coordinate one Neighborhood Response Team CERT Drill in Venice. Date: TBD

- Staff Outreach Table at Venice Holiday Sign Lighting. Date: December 2026

- Coordinate one CPR and one first aid refresher class.
