A.MOTION TO ADOPT STANDING RULES OF DECORUM (Nico Ruderman)

MOTION: That the Venice Neighborhood Council hereby adopts the following Standing Rules of Decorum, which shall apply to all General Board Meetings and Committee Meetings, effective immediately upon adoption and remaining in force until amended or repealed by a majority vote of the Board.

DESCRIPTION

- Neighborhood Council meetings exist to serve the community through respectful, civil, and efficient deliberation; and
- Some recent meetings of the Venice Neighborhood Council have become contentious, with repeated personal conflicts, disruptive conduct, and excessive commentary interfering with the Council's ability to complete its business; and
- In the interest of both decorum and timeliness, it is necessary to establish clear expectations and procedures to ensure that meetings are conducted efficiently and do not unreasonably burden this volunteer board and the public; and
- The Board has a responsibility to set clear standards of conduct and procedures to ensure all participants—Board Members and members of the public—can be heard without intimidation or disruption;

B.MOVE BOARD MEETINGS TO PENMAR REC (Lisa Redmond)

MOTION:_The Venice Neighborhood Council moves to hold its monthly Board of Officers regular meetings at the Multipurpose Center located at the Penmar Recreation Center for the remainder of the 2025-26 fiscal year.

DESCRIPTION: The Los Angeles budget crisis has trickled down to Neighborhood Councils and the allotted \$32,000 annual budget for the last several years has now been reduced to \$25,000 for this new fiscal year, which began July 1, 2025. A loss of \$7,000 is palpable and the Venice Neighborhood

1222 Abbot Kinney (8-0-1)

MOTION: Conversion of an existing single-family dwelling and ground floor retail to retail only, relocate dwelling unit to a new 366 sq. ft. live/work dwelling unit at rear of property. https://planning.lacity.gov/pdiscaseinfo/search/casenumber/ ZA2024-6672-ZV-CDP-SPPC-ADJ-MEL

DESCRIPTION: The Venice Neighborhood Council LUPC recommends that the Venice Neighborhood Council supports the City's approval of a Coastal Development Permit (CDP), a Specific Plan Project Compliance Permit (SPPC) and an Adjustment (ADJ) for the project at 1222 Abbot Kinney for the remodel of an existing single-family dwelling and ground floor retail building to be retail in the front of the property, on the condition that the 311 SF live/work unit is changed to a single-family dwelling (replacing the existing garage at the rear of the property) that is a minimum of 768 SF, the size of the original building (2-story is OK), with 2 long-term and 4 short-term bicycle parking spaces provided (long-term provided in the public right-of-way) and no car parking provided (AB 2097 exemption)

interest of the VNC to renew our contract with Web Corner for the fiscal year July 1, 2025 – June 30, 2026. The terms remain identical - \$150/mo for hosting which includes 1hours/month of tech support. The budget also includes annual domain registration. Total annual expenditure is \$1,830.

17. INCREASE ON TRASH FEES (Shaun O'brien)

MOTION: Prepare A Protest letter regarding the Increase consideration adoption of charges to the SOLID RESOURCES FEE, rates and consider all written protests against the proposed rates.

DESCRIPTION: Shaun Obrien, and Yolanda Gonzalez will present the proposed increased rates, from 36%to 63%, on individuals, and property owners, of PROPOSITION 218..The form of protest must be in by 9/30/2025
