- 1.a I have not served on the LUPC, or a similar committee before.
- 1.b I'm a licensed architect in California, with 35 years of experience here in SoCal in a wide range of building types. I have dealt with building and planning departments, entitlements, CUPs and various kinds of City and County approvals. I'm familiar with how the building codes, and the zoning and planning requirements work, and the processes which review and comment on projects as they proceed through the required approvals.
- 1.c I would expect that there are documents to review for each project that would take some time to become familiar with, and possibly require some research. There would also be preparation for each meeting for items on the agenda, and the issues that might arise. The time commitment required would vary, but might be substantial from time to time.
- 2. I have not been previously involved in community organizations, other than voting. I have lived in Venice for 32 years and have watched the community change a great deal, especially in the past ten years. I decided that it is time I did get involved.
- 3. The three most critical issues facing Venice:
  - a. Affordable housing for varied income levels.
  - b. Unhoused people how to humanely continue to address their needs in the short term and transition them to permanent homes.
  - c. Maintain the historically diverse neighborhoods and varied architectural and cultural characters of Venice as the needs and ambitions of the community continue to evolve.
- 4. The Venice Land Use Plan seems to be a refined, reasoned look at how Venice might grow. The number of categories of use, and the clear succinct descriptions given, demonstrate how much thought, work and care has gone into the preparation of the document to date. I found the distribution of uses and modulated building forms convincing, with a recognition of the importance, and a commitment to maintaining the character of Venice.

The Venice Coastal Zone Specific Plan dating from about 2001 and earlier, is an older document. The policies and priorities it identifies are familiar, relevant, and still largely applicable to the area, though couched in broader language than the City document, given that it is responding to state law and the priorities of that time. The land use maps appear to be roughly congruent in intent with a good deal of the current City documents.

- 5. In private interactions, I would view my role as representing the committee, and would comment on simple questions of how to submit, or when to submit documents or questions, but not comment on any substantial private concerns the individuals might have.
- 6. From what I have read, the conflicts of interest and ethics requirements seem reasonable, and I would agree to follow them.
