7. UPDATE ON VENICE BEACH ACCESSIBILITY PROJECT

DESCRIPTION: In February of 2025, the VNC Board passed support for a stakeholder-submitted Venice Beach Accessibility Project.

DESCRIPTION: WHEREAS, Venice beaches have long stretches of sand spanning from the ocean water to the Boardwalk which results in long walk times WHEREAS, only individuals that can physically make the walk to the water can enjoy the water; WHEREAS, other users such as ADA impaired, senior citizens, families with young kids, bicyclists, or constituents with lots of beach items in hand to enjoy the water are unable to access the ocean as freely or easily as they would like;

MOTION: Venice Neighborhood Council (VNC) supports the Venice Beach Accessibility Project which would construct either permanent or semi-permanent walkways at several locations (yet to be determined, see supporting documents attached) at Venice beaches to allow for greater accessibility to the water for everyone.

DISCUSSION/POSSIBLE MOTION: OFW committee will follow up and discuss next steps, current project status, funding possibilities, government agencies involved, and a possible location.

The OFW pagodas are beloved historical iconic Venice landmarks. Many are now in need of repair, refurbishment, and/or restoration.
