Every person wishing to address the Board must dial telephone number listed above, and enter the above Meeting Id number and then press # to join the meeting. When prompted by the presiding officer, to provide public input at the Neighborhood Council meeting the public will be requested to dial \*9 or use the Raise Hand option, to address the Board on any agenda item before the Board takes an action on an item.

Comments from the public on agenda items will be heard only when the respective item is being considered. Comments from the public on other matters not appearing on the agenda that are within the Board's jurisdiction will be heard during the General Public Comment period.

Please note that under the Brown Act, the Board is prevented from acting on a matter that you bring to its attention during the General Public Comment period; however, the issue raised by a member of the public may become the subject of a future Board meeting.

Public comment is limited to 30 seconds per speaker, unless adjusted by the presiding officer of the Board. In the event of a disruption that prevents the eligible legislative body from broadcasting the meeting to members of the public using the call in option or internet-based service option, or in the event of a disruption within the eligible legislative body's control that prevents members of the public from offering public comments using the call-in option or internet-based service option, the eligible legislative body shall take no further action on items appearing on the meeting agenda until public access to the meeting via the call-in option or internet-based service option is restored.

Actions taken on agenda items during a disruption that prevents the eligible legislative body from broadcasting the meeting may be challenged pursuant to Section 54960.1.(C) The eligible legislative body shall not require public comments to be submitted in advance of the meeting and shall provide an opportunity for the public to address the legislative body and offer comments in real time. Notwithstanding Section 54953.3, an individual desiring to provide public comment by using an internet website, or other online platform, not under the control of the eligible legislative body, that requires registration to log in to a teleconference may be required to register as required by the third-party internet website or online platform to participate. (E) (i) An eligible legislative body that provides a timed public comment period for each agenda item shall not close the public comment period for the agenda item, or the opportunity to register, pursuant to subparagraph (D), to provide public comment until that timed public comment period has elapsed. (ii) An eligible legislative body that does not provide a timed public comment period, but takes public comment separately on each agenda item, shall allow a reasonable amount of time per agenda item to allow public members the opportunity to provide public comment, including time for members of the public to register pursuant to subparagraph (D), or otherwise be recognized for the purpose of providing public comment. (iii) An eligible legislative body that provides a timed general public comment period that does not correspond to a specific agenda item shall not close the public comment period or the opportunity to register, pursuant to subparagraph (D), until the timed general public comment period has elapsed.

Comments from the public on other matters not appearing on the agenda that are within the Board's jurisdiction will be heard during the General Public Comment period. Please note that under the Brown Act, the Board is prevented from acting on a matter that you bring to its attention during the General Public Comment period; however, the issue raised by a member of the public may become the subject of a future Board meeting. Public comment is limited to Two (2) minutes per speaker, unless adjusted by the presiding officer of the Board.

## 10. Digital Media Policy

Motion: The VNC Board of Officers hereby adds the following to its Standing Rules: Digital Media Policy - Social Media

- 1. The VNC formally nullifies any previously-approved or informal in-use, invalid social media standard operating procedures (SOP) which is overridden by the BONC-approved "Board of Neighborhood Commissioners' Digital Communications Policy for the Neighborhood Councils." The BONC policy is the official digital communication policy for all neighborhood councils. It states: "This policy applies to all certified neighborhood councils and governs the use, management, design, development and maintenance of Digital Communications accounts, platforms, and tools utilized by neighborhood councils." Hierarchy of BONC policy vs NC policy: BONC Policies Override NC Policies BONC is the governing body that sets citywide policy standards for all 99 Neighborhood Councils. These policies are binding on NCs meaning: Any NC policy or action that contradicts an existing BONC policy is invalid and unenforceable, even if approved by a vote of the NC board. Examples of BONC policies: Digital Communications Policy Code of Conduct Policy 1 Uniform Bylaws Template Board Member Removal Policy These apply uniformly across all NCs, and NCs cannot "opt out" or override them through local votes.
- 2. In accordance with the roles identified by the BONC Digital Communications Policy for the Neighborhood Councils, the VNC will have an Account Administrator which will be the VNC President and a Content Creator which will be the VNC Outreach Chair.

- c. Committee Discussion/Vote: Our NC has not been adhering to standards set forth Unanimous agreement our NC needs to fall in line with the other 99 NCs and adopt the common appointments of responsibility to increase accountability.

**a. The Committee will also invite the Communications Chair to a future meeting for a transparent, public discussion on aligning Standing Rules with the Bylaws, clarifying committee responsibilities, and evaluating which Outreach tasks may appropriately fall under the Communications Committee's purview. All discussions will take place publicly to ensure transparency and to avoid any ex parte communication.
