5. OLD BUSINESS

- a. Motion Right-of-Way PROTECTION OF THE TREES on Venice Blvd - NEXT STEPS - Lucy and her husband built on Venice and were not informed about the previously existing planting plan, and when they took the old plan to BOE, they were told that permit was closed and no longer relevant. We are still waiting on Sean Silva to get a meeting together with BOE and Urban Forestry. Lucy asked for us to remove the R-Permit since it names her and her husband. Vincent Autiero of Department of Neighborhood Empowerment asked that Lucy send a formal request. Lucy and husband want to plant native plants and trees for pollinators.
 - i. We need to get BOE on track to refer owners to the old planting plan when they give out R-permits.
