Nominations were opened at the September 15th Board meeting at which time it was announced that applications will be available on the front page of the <u>VNC website</u>. They must be returned by email to john.reed@venicenc.org by **October 12th at 7PM** for the VNC Adcom zoom meeting. at which time the nominations will be closed. The Board will select a new member at the **October 20th** Board zoom meeting. Applicants need to show proof that they are stakeholders either at the Adcom or Board meetings and may be given a short presentation at the Board meeting. No representatives will be permitted to speak for the applicant. Applicants are encouraged to provide background information regarding their technical qualification for this open seat.
