~~Subcommittees must follow the same operational rules that the VNC applies to ad-hoc committees except that they report to their parent body, not the VNC Board.~~

~~This means that the parent body must make motions that create sub-committees; define their subject matter (and or mission if a mission statement is necessary) and duration; and dissolve them when necessary if they are not term-limited. Committee chairs are responsible for any subcommittees created by their committees. They report to the Board and take responsibility for subcommittee activities in the same way the President and Vice President are responsible for committees. B1 **Support for Short Term Vacation Rentals Motion in City Council (15 minutes)** Marc Saltzberg

MOTION: The Venice Neighborhood Council supports Los Angeles City Council motion 14-1635 requesting that the Council direct the City Administrative Officer and the Chief Legislative Analyst, in conjunction with the relevant City Departments and the City Attorney to work with stakeholder groups to make recommendations for an ordinance regulating the legal operation of short-term rentals in Los Angeles that (a) protects residential neighborhoods from large numbers of or a concentration of short term rentals in any particular neighborhood at a given time; (b) provides for collection of the Transit Occupancy Tax; and (c) prohibits the removal of large numbers of units from the City's stock of rental or affordable housing. We agree that it makes sense to examine the experience of other states and municipalities in developing such regulations.

The VNC urges LA City to compile more information on the number of short-term rentals in residential zones throughout the City, and in Venice in particular. The VNC passed the following motion on 10/21/2014: The VNC Board shall request the CAO to compile and provide information on the number of short-term rentals in Venice, including the number of single-family dwellings where only one dwelling unit exists on the lot, the number of multi-family dwellings, including duplexes and condominiums, and the number of listings, whether registered or unregistered properties, that fall under the Rent Stabilization Ordinance.

Per our request to involve stakeholder groups, the VNC sent a letter to the Los Angeles City Council on September 24, 2014 regarding Council File Council File 14-0593, which created the Sharing Economy Work Group. The letter stated, in part: "the Venice Community deserves to be included in preparing the Work Group's report and recommendation to the City Council; and that the VNC Board recommends that... the Work Group focus on the positive and negative impacts of the recent exponential expansion of the short-term rental market on Venice..., and that they carefully research and analyze the impact of non owner-occupied short-term rentals on the availability of longterm housing stock in Venice, the number of rent controlled units in Venice, and on the quality of life and socio-economic diversity in Venice's residential neighborhoods (including commercial zones with rent-controlled properties).

We also wish to remind the Los Angeles City Council that on August 8, 2014, the VNC submitted a CIS re: Council File Council File 14-0593 requesting that Sharing Economy Working Group consider a report dated Nov. 7, 2013 by the VNC Neighborhood Committee regarding Short Term Vacation Rentals. In the meantime, the VNC urges the City to enforce current laws to protect our communities.

MOTION: The Venice Neighborhood Council Board approves the following Community Impact Statement (CIS) in response to City Council File 14-1635 and other short-term rental legislation:

Venice Neighborhood Council Community Impact Statement--Analysis of Impact of Short-Term Rentals

In order to adequately analyze and consider potential impacts on Venice prior to City Council decisions on changes to current Zoning Codes, General Plan and Community Plan and prior to preparation of an ordinance regulating and governing the legal operation of short-term rentals in Los Angeles, and in order to consider the Mayor's recently announced plan to improve L.A. Residents' lives, the Venice Neighborhood Council (VNC) specifically supports and requests the following:

1. The City Administrative Officer to compile and provide information on short-term rentals in residential zones in Venice, including an independent inventory of the total number of short-term rentals in Venice, including the number of single-family dwellings where only one dwelling unit exists on the lot, the number of multi-family dwellings, including duplexes and condominiums, and the number that are located outside the traditional hotel/visitor-serving areas; and to provide an audit of the number of listings, whether registered or unregistered properties, that fall under the Rent Stabilization Ordinance.
2. The Chief Legislative Analyst to work with VNC representatives to analyze the positive and negative impacts of the recent exponential expansion of the short-term rental market in Venice on the availability of long-term housing stock in Venice, the number of rent-controlled units in Venice, and on the quality of life and socio-economic diversity in Venice's residential neighborhoods, including commercial zones with rent-controlled properties, including a separate analysis of the impact of non owner-occupied short-term rentals, including a separate analysis of the impact of the "middle-man" rental management companies, and including consideration of the information in a report on Short-Term Vacation Rentals, dated November 7, 2013, prepared by the VNC Neighborhood Committee: <http://www.venicenc.org/wp-content/uploads/2012/09/Short-Term-Vacation-Rental-Report.pdf>
3. The Chief Legislative Analyst to work with VNC representatives to research and evaluate/examine the experience and best practices of cities such as S.F., Portland, New York and other cities in California and other states, to review recent legislation and to consider the effective controls and enforcement processes needed to protect residential communities, both with regard to short-term rentals that may currently operate legally and with regard to the legalization of short-term rentals where they are currently illegal. Such examination would include evaluation of controls and processes used to assure protection of the quality of life and right to quiet enjoyment of one's premises in Venice's residential neighborhoods from large numbers or a concentration of short-term rentals, evaluation of processes for collection of applicable fees and taxes, and an evaluation of controls utilized to prohibit the removal of significant numbers of units from the City's stock of long-term rental housing, including and especially low income /affordable housing.
4. Based on the results of such research and examination, the Chief Legislative Analyst to work with
